WHEREAS, the parties entered into a Service Contract to provide Summer Youth Employment Training Program services on April 3, 2018 ("Original Agreement") and approved by City Resolution No. 2018-117; and

WHEREAS, the parties entered into a First Amendment and a Second Amendment of the Original Agreement extending the contract for additional one-year periods; and

WHEREAS, the parties now desire to extend the Original Agreement for a third additional one-year period, and to amend certain terms and conditions by substituting Exhibit A, "Scope of Service," and Exhibit C, "Narrative Report," to the Original Agreement.

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

- 1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
- 2. The Original Agreement effective April 3, 2018, and subsequently amended on April 1, 2019, by Resolution No. 2019-138 and on March 12, 2020, by Resolution No. 2020-154, copies of which are attached hereto and made a part hereof as Composite Exhibit "1," shall remain in full force and effect except as specifically amended hereinbelow.
- 3. The parties hereto agree to extend the Original Agreement for one (1) additional one-year period, ending on April 2, 2022.
- 4. The attached Exhibit "A" is hereby substituted for, and in all references replaces, that Exhibit "A" which was attached to, referenced, and made a part of the Original Agreement.
- 5. The attached Exhibit "C" is hereby substituted for, and in all references replaces, that Exhibit "C" which was attached to, referenced, and made a part of the Original Agreement.
- 6. All other terms and conditions of the said agreement shall remain in full force and effect as provided by the original agreement and any previous amendments and renewals thereto, unless earlier terminated pursuant to the provisions of the agreement.
- 7. That no other amendment to the terms of the said agreement shall be effective unless contained in a written document executed with the same formality and of equal dignity herewith.
