The City is requesting that the property be upgraded to be in compliance with the site plan that was approved in 2007. Basically replace dead and dying trees, upgrade planting, fix curbs, etc.

In addition, the engineering department has requested the stormwater license approvals.

I checked on Enviro and I cannot find the a license for this property. Back in 2007, a new site plan was submitted and stormwater improvements were made, please see attached. Do you know if a SWM license exists for this property? When I looked on Enviro there were hazardous materials licenses, but no SWM. Maybe I'm not looking in the right place.
