LOGO, TYPEFACES, & COLORS

LOGO

- a. Logos are permitted for only nationally recognized brands with established signage guidelines
- b. Logos or logo elements for national brands shall be clear and legible for the size proposed
- c. Retailers that do not fall into the category above shall use an approved bold sans serif font from the options below.
- d. Signs utilizing legally registered and recognized logos, trademarks or letter styles and colors that differ from the shopping center's sign criteria guidelines may be allowed subject to approval by the planning and zoning department of Pompano Beach and the landlord.

TYPEFACES

Allowable fonts/typefaces for channel letters and tenant signage panels are as follows:

- a. Arial / Arial Bold
- b. Proxima Nova / Proxima Nova Bold
- c. Bebas Neue Bold

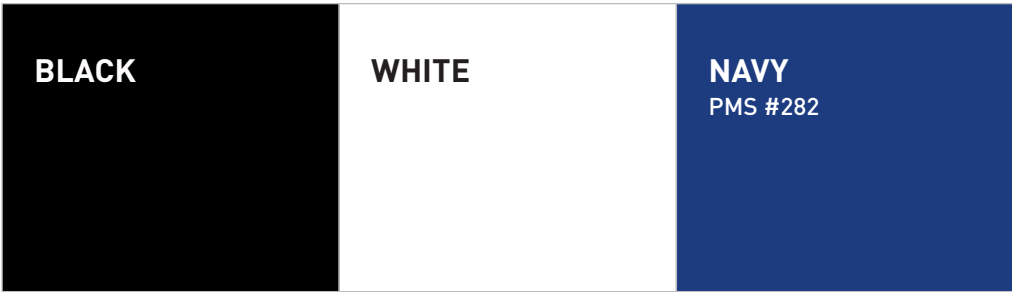
