WHEREAS, the CITY and CONTRACTOR have mutually agreed to implement an additional module to MaintenanceEdge, Capital Forecast Evaluation and Work Order Module, and add yearly maintenance fee to the module, which shall be concurrent to the existing software maintenance.

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONTRACTOR agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.

- 2. The terms and conditions contained within the Original Agreement between CITY and CONTRACTOR, effective April 28<sup>th</sup>, 2017, a copy of which is attached hereto and made a part hereof as Exhibit "1," shall remain in full force and effect except as specifically amended hereinbelow.
- 3. Exhibit A, Scope of Work, is hereby substituted for, and in all references replaces, that Exhibit A, Scope of Work, which was attached to, referenced and made a part of the Original Agreement.
- 4. Exhibit B, Insurance Requirements, is attached hereto and by reference incorporated herein and made a part hereof.
- 5. Paragraph 6, Price Formula, is hereby deleted in its entirety and a new Paragraph 6
  Price Formula is hereby substituted as follows:
  - 6. <u>Price Formula</u>. City shall pay the implementation cost of the Capital Forecast and Work Order Module of \$56,710.00 upon completion of the services. Maintenance fees shall be paid in accordance with the below schedule:
