## **City Commission Meeting**

## CALL TO ORDER

The Honorable Rex Hardin, Mayor called the City Commission meeting to order at 1:00 p.m.

The Commission may pull items from the Consent Agenda. During Audience to be Heard, a person may speak on any item on the Consent Agenda, which has not been pulled.

Mayor Hardin announced that Items 9, 10 and 11 would be pulled for City Commission discussion.

#### A. AUDIENCE TO BE HEARD

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

**Rodrick Phillips, 2620 NW 10th Street, Pompano Beach, FL,** thanked Comr. Moss for the Superbowl event. He also thanked BSO on behalf of the Tiger Trail Festival. He recognized Comr. Fournier and Mayor Hardin's attendance at all the Black History Month events and their commitment to inclusion. He stated that BSO is doing an excellent job helping the homeless and cleaning up the area.

**Pat Anderson, 2650 NE 24th Street, Pompano Beach, FL,** commented on a structure that was built in her cul-de-sac, which resulted in property damage. She stated that she had been bringing this issue to the Commission's attention for the past 7 years. Ms. Anderson also mentioned that she had to take out a loan to address the code violations cited against her property. Furthermore, she pointed out that all the overlays in relation to her property are incorrect, and therefore, she requested to receive a clear title insurance.

**Dana Golson, 629 NW 21st Avenue, Pompano Beach, FL,** provided an update on issues she previously raised. She expressed her gratitude to Code Compliance and BSO for meeting with her and providing her with excellent guidance. She mentioned that at least 10 of the streetlights that were not working have been replaced, and the gates are now operational. She thanked Comr. Moss for his guidance and direction.

Furthermore, she raised concerns about the non-compliance of grants with regards to some homes in her area that are not owner-occupied and have issues. She requested assistance to address this issue, as it is a disservice to the City and the grant program. She specifically mentioned 4 homes that are in non-compliance.

Mayor Hardin directed Ms. Golson to City Attorney Berman for further assistance. Ms. Golson submitted documentation to the City Clerk.

Ed Phillips, 384 NW 19th Street, Pompano Beach, FL, commended Ms. Golson and her diligence in keeping her neighborhood updated to maintain the quality of the community. He announced the upcoming Ban the Books event on February 24th and invited the Commission to attend.

Mary Phillips, 384 NW 19th Street, Pompano Beach, FL, announced the meeting concerning the \$10M reallocated to the Northwest Community will be held on February 15th. She said the money should be spent on hardening of homes and allowing residents to remain in their homes and improving their quality of life.

Mayor Hardin explained that the Residential Advisory Board, established by the Broward County Commission, is responsible for advising on how to spend \$10 million in the Northwest section. He clarified that the City of Pompano Beach has no control over the spending of this money.

Matthew Hermann, 121 NE 8th Street, Pompano Beach, FL, raised some concerns. He mentioned that the roads in the area are too small and there are no sidewalks. He suggested installing speed bumps to help alleviate the issue. He also highlighted the problem of illegal dumping, including bags of trash from Family Dollar. Mr. Hermann expressed interest in creating a community garden in the area as well.

Mr. Hermann also stated that he has additional topics regarding peace and unity that he would like to discuss with Comr. Fournier. He mentioned that he plans to initiate a petition to remove Family Dollar from the area.

Mayor Hardin thanked him for his efforts to work with Code Compliance. Comr. Fournier asked Mr. Hermann to contact her directly.

Kathleen Angione, 740 NE 26th Avenue, Pompano Beach, FL, expressed her gratitude for the work that the Commission does for the City. She also announced her candidacy for Judge and took the opportunity to introduce herself to the attendees. Finally, she requested support from those present in the upcoming election.

Comr. Fournier pulled the item for Ed Phillips.

Ed Phillips, 384 NW 19th Street, Pompano Beach, FL, inquired about the Affordable Housing Trust Fund. Mayor Hardin clarified that the fund is established to be used for affordable housing purposes. However, Mr. Phillips wanted to know how the City defines affordable housing, not using the definition provided by HUD. Furthermore, he inquired about the number of units that will be considered affordable. Mayor Hardin clarified that the project is already affordable housing. Mr. Phillips expressed that he is advocating on behalf of those who are trying to find solutions for affordable housing.

Alex Goldstein, OHUI Compliance Manager, said they are bound by the federal guidelines. He said he can send the regulations to Mr. Phillips. Mr. Phillips said Mr. Goldstein should have those numbers readily available to share.

Mr. Phillips asked if a specific number of affordable housing units have been set aside. Mr. Goldstein replied they set aside 10 units for very low income in the Sonata and Captiva projects as part of the development agreement. Mr. Phillips asked what criteria is used to determine eligibility for the units. Mr. Goldstein responded the criteria to determine eligibility for the units are forthcoming. Mr. Phillips said it appears that local Pompano Beach residents do not have preference for affordable housing units.

Mayor Hardin asked if they could have set-aside units for Pompano Beach residents. Mr. Goldstein replied they could consider it. Mr. Phillips said the City needs to do a PR campaign to highlight good things that happen for Pompano Beach residents.

Comr. Fournier acknowledged the 10 units set aside for very low income but asked about the status of the rest of the units. Mr. Goldstein asked representatives from the Cornerstone Group to respond.

Josh Tonnesen, Cornerstone Group, stated he does not know the exact unit mix but said the IRS regulations demand an average of 60% Area Median Income (AMI). He believes they actually have 15 units for very low income.

Comr. Fournier asked if the units are already rented. Mr. Tonnesen said Sonata is approximately 97% full. He said they set up a booth in the City in order to attract local renters first. Comr. Fournier asked about the \$25,000 amount in relation to the item. Mr. Tonnesen replied it pertains to overruns in supply, which is largely due to the cost of supplies. Comr. Fournier asked if they could prioritize Pompano Beach residents. Mr. Tonnesen said they cannot, but they typically build in local leasing efforts for the first 15-30 days.

Lenny Wolfe, Cornerstone Group, said they could setup in City Hall and distribute information to local residents. He said they can informally prioritize a couple months in advance. Comr. Fournier asked them to contact Cassandra Rhett, the Housing and Social Services Manager, when an affordable unit becomes available. Mr. Wolfe said he can provide information about how many units were rented by Pompano Beach residents in Sonata.

Mayor Hardin asked why they cannot formally prioritize Pompano Beach residents. Mr. Wolfe replied they would likely get sued.

Mayor Hardin sought public input on the item and, receiving none, he moved on to Commission discussion.

Vice Mayor McGee inquired whether it would be possible to provide Ms. Rhett with a list of Pompano Beach pre-applicants. Mr. Goldstein said he can work with Ms. Rhett on the suggestion.

Comr. Sigerson-Eaton commended the Cornerstone Group and said they have done a great job on the Sonata project and she supports the item. She hopes they will do more projects in Pompano Beach.

Mr. Wolfe noted they have not begun pre-leasing on the 106 Captiva units, however he is committed to working with Ms. Rhett, and is happy to set up a table in City Hall.

Comr. Sigerson-Eaton said she heard Pompano Beach has the most affordable housing units in the County, but she heard from Mayor Hardin and Comr. Fournier that Fort Lauderdale had more. She emphasized that there are other cities in Broward County that have no affordable housing projects.

Comr. Perkins said the number one issue in her district is the need for affordable housing. She would love to see this developer put up more affordable apartments in the area. She has no issues with the Resolution because it is a loan. She noted that staff is pushing for market rate and many residents in her district cannot afford them.

Comr. Moss agreed with Comr. Perkins but echoed Comr. Sigerson-Eaton's comments about other communities not doing their fair share in providing affordable housing.

Comr. Fournier said this is an opportunity to talk about the City's needs with these projects and future ones. She noted that Fort Lauderdale has twice as many income-restricted units. She acknowledged, per capita, they are doing more than most cities but Pompano Beach and Fort Lauderdale are bearing the burden of providing affordable housing.

Comr. Fournier asked for an update on Pompano Beach youth baseball.

Mark Beaudreau, the Recreation Director, introduced the item and reported that they had a successful in-house youth baseball program. They are now continuing that success by bringing in the Florida Pokers.

Comr. Fournier asked if they are bringing existing teams to use the facilities or is the organization going to establish all new teams with Pompano Beach children. Mr. Beaudreau replied that at least 25% of the teams will be filled by Pompano Beach children.

Ryan Combs of Florida Pokers Travel Baseball, Inc. expressed their goal to have all teams comprised of Pompano Beach kids. Accordingly, they plan to hold tryouts within the area to form the teams.

Mayor Hardin sought public input on the item and, receiving none, he moved on to Commission discussion.

Comr. Moss inquired about travel baseball. Mr. Beaudreau explained that it is an advanced team that travels to different cities to play.

Mayor Hardin inquired about the Florida Pokers. Mr. Combs clarified that while the organization currently has high school teams, they do not yet have any youth teams. This allows students to develop their skills within the sport and gain greater exposure.
