

LEGAL DESCRIPTION:

A PORTION OF LOT 3, MANZO MAR, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 27, PAGE 27, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID LOT 3; THENCE ALONG THE NORTH LINE OF SAID LOT 3, NORTH 74°08'09" EAST, 132.72 FEET TO A POINT ON THE WET FACE OF AN EXISTING SEAWALL, SAID POINT ALSO BEING ON THE MEAN HIGH WATER LINE OF SANTA BARBARA LAKE; THENCE ALONG SAID SEAWALL AND MEAN HIGH WATER LINE THE FOLLOWING TWO (2) COURSES: (1) SOUTH 06°41'31" WEST, 82.67 FEET TO A POINT OF CURVATURE OF A CURVE TO THE RIGHT WITH A RADIUS OF 310.18 FEET; THENCE (2) ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 3°50'04" AND AN ARC LENGTH OF 20.76 FEET; THENCE NORTH 80°23'20" WEST, 145.48 FEET TO THE EAST RIGHT OF WAY LINE OF CIRCLE DRIVE; THENCE ALONG SAID EAST RIGHT OF WAY LINE, NORTH 34°08'09" EAST, 50.81 FEET TO THE POINT OF BEGINNING.

SAID LANDS LYING IN THE CITY OF POMPANO BEACH, BROWARD COUNTY, FLORIDA, AND CONTAINING 9,713 SQUARE FEET (0.22 ACRES), MORE OR LESS.

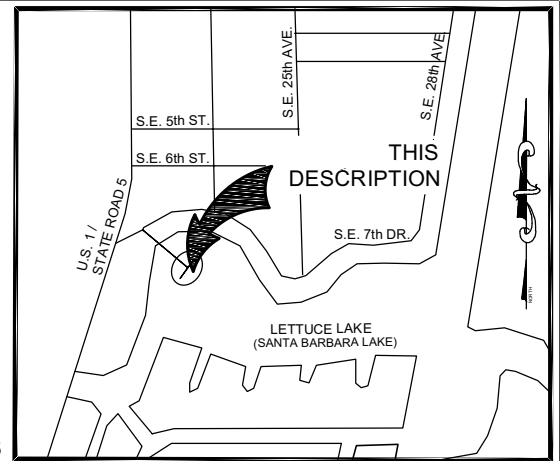

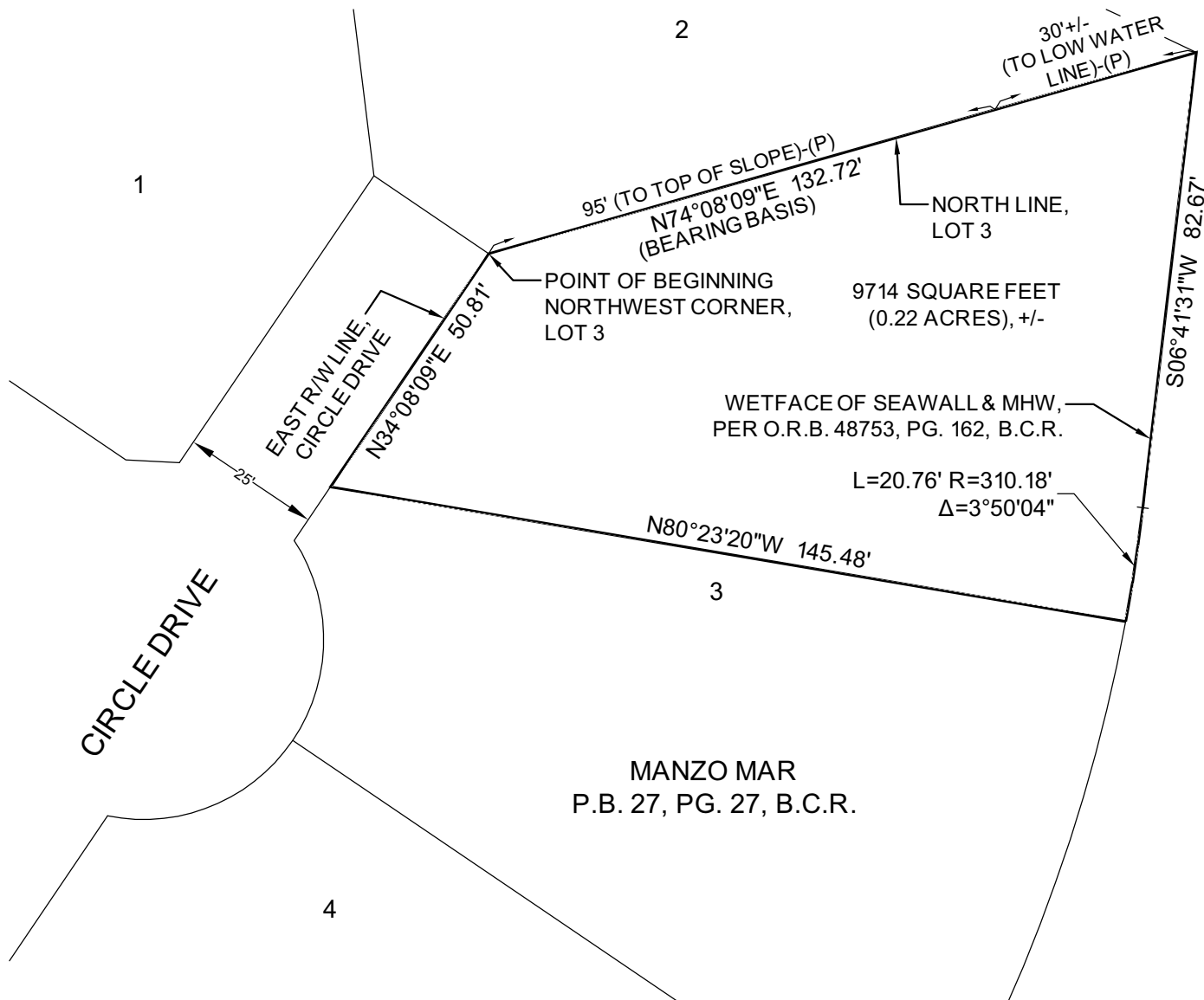
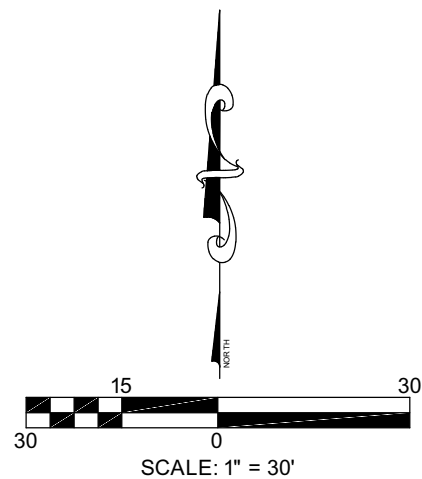
