ALL THAT PART OF THE W. 1/2 OF THE E. 1/2 OF THE N.W. 1/4 OF THE SW. 1/4 OF SECTION 30, TOWNSHIP 48 SOUTH, RANGE 43 EAST, LYING EAST OF THE FEDERAL HIGHWAY (STATE ROAD NO. 5 AND U.S. HIGHWAY NO. 1 - FORMERLY STATE ROAD NO. 4) AND LYING SOUTH OF A LINE PARALLEL TO AND 360 FEET SOUTH OF THE NORTH LINE OF THE SW. 1/4 OF SAID SECTION 30; ALSO ALL THAT PART OF THE E. 1/2 OF THE SW. 1/4 OF THE N.W. 1/4 OF THE SW. 1/4 OF SAID SECTION 30 LYING EAST OF SAID FEDERAL HIGHWAY; ALSO LOTS 30 AND 31 OF CALIBAN, ACCORDING TO THE PLAT THEREOF RECORDED IN PLAT BOOK 27, PAGE 12, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA.
