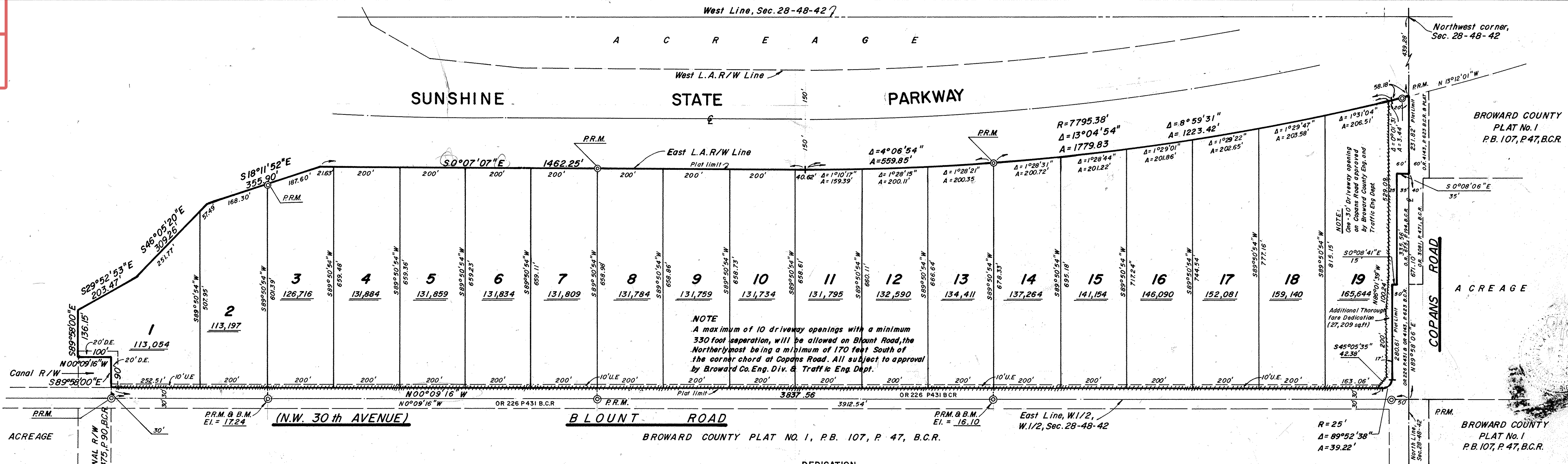

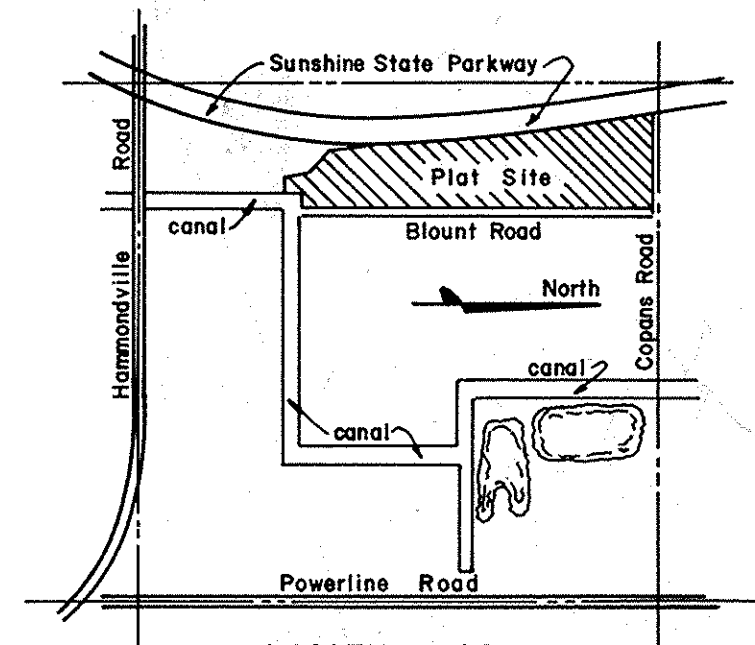
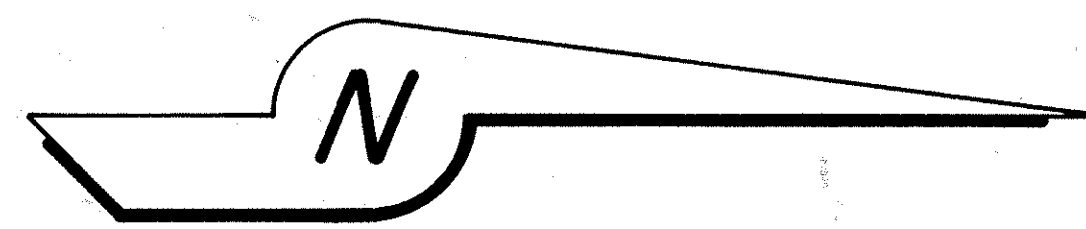


**DESCRIPTION**

A portion of the West one-half (W.1/2) of the West one-half (W.1/2) of Section 28, Township 48 South, Range 42 East, more fully described as follows:  
All that part of the West one-half (W.1/2) of the West one-half (W.1/2) of said Section 28 lying East and North of the Easterly right-of-way line of the Sunshine State Parkway, LESS the North 50 feet of the East one-half (E.1/2) of the East one-half (E.1/2) of the Northwest one-quarter (N.W.1/4) and LESS the North 35 feet of the West one-half (W.1/2) of the East one-half (E.1/2) of the Northwest one-quarter (N.W.1/4) of the Northwest one-quarter (N.W.1/4), and LESS the East 30 feet thereof, and LESS that certain 100 foot canal right-of-way lying West of Blount Road, and all LESS that external area of a 25 foot radius curve lying at the Northeast corner of said property.
