

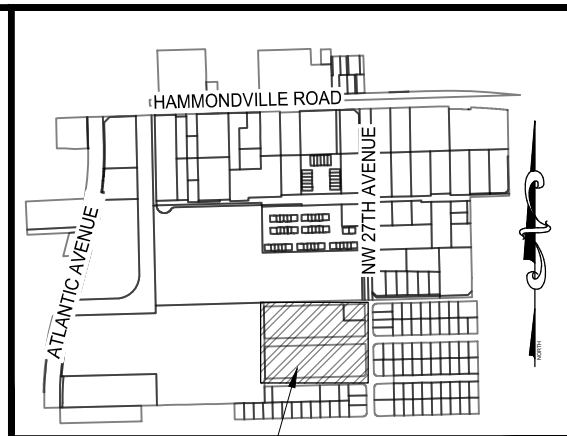

LEGAL DESCRIPTION:

A PORTION OF SECTION 33, TOWNSHIP 48 SOUTH, RANGE 42 EAST, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT THE NORTHEAST CORNER OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 OF SECTION 33, TOWNSHIP 48 SOUTH, RANGE 42 EAST; THENCE SOUTH 89°55'31" WEST ALONG THE NORTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SAID SECTION 33 A DISTANCE OF 40.00 FEET TO THE POINT OF BEGINNING; THENCE SOUTH 00°20'10" WEST 25.00 FEET; THENCE SOUTH 89°55'31" WEST 600.88 FEET; THENCE NORTH 00°14'52" EAST 25.00 FEET TO A POINT ON SAID NORTH LINE AND ALSO ON THE SOUTH LINE OF TRACT "A", "SCHOOL SITE 3220", ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 149, PAGE 50 OF THE PUBLIC RECORDS OF BROWARD COUNTY FLORIDA; THENCE ALONG SAID LINE, NORTH 89°55'31" EAST 600.92 FEET TO THE POINT OF BEGINNING.

SAID LANDS LYING IN THE CITY OF POMPANO BEACH, BROWARD COUNTY FLORIDA AND CONTAINING 15,022 SQUARE FEET (0.34 ACRES) MORE OR LESS.

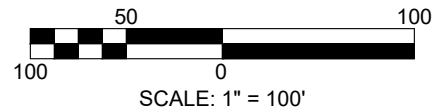
