AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE SERVICE CONTRACTS FOR WELL REHABILITATION AND MAINTENANCE BETWEEN THE CITY OF POMPANO BEACH AND FLORIDA DESIGN DRILLING CORP., A.C. SCHULTES OF FLORIDA, INC., AND ALL WEBBS ENTERPRISES, INC., TO PROVIDE POTABLE WATER PRODUCTION AND RELATED SERVICES (RLI 25-056); PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to law, ten (10) days' notice has been given by publication in a newspaper of general circulation in the City, notifying the public of this proposed ordinance and of a public hearing in the City Commission Chambers of the City of Pompano Beach; and

WHEREAS, a public hearing before the City Commission was held pursuant to the published notice described above, at which hearing the parties in interest and all other citizens so desiring had an opportunity to be and were, in fact, heard; now, therefore,

BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the Service Contract for ITB 25-056 - Well Rehabilitation and Maintenance between the City of Pompano Beach and Florida Design Drilling Corp. (No. 13022), to provide potable well maintenance, copies of which Agreement is attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

SECTION 2. That the Service Contract for ITB 25-056 - Well Rehabilitation and Maintenance between the City of Pompano Beach and A.C. Schultes of Florida, Inc. (No. 13123), to provide potable well maintenance, copies of which Agreement is attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

SECTION 3. That the Service Contract for ITB 25-056 - Well Rehabilitation and Maintenance between the City of Pompano Beach and All Webbs Enterprises, Inc. (No. 13124), to provide potable well maintenance, copies of which Agreements is attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

SECTION 4. That the proper City officials are hereby authorized to execute said Agreements between the City of Pompano Beach and A.C. Schultes of Florida, Inc., Florida Design Drilling Corp., and All Webbs Enterprises, Inc.

SECTION 5. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 6. This Ordinance shall become effective upon passage.
