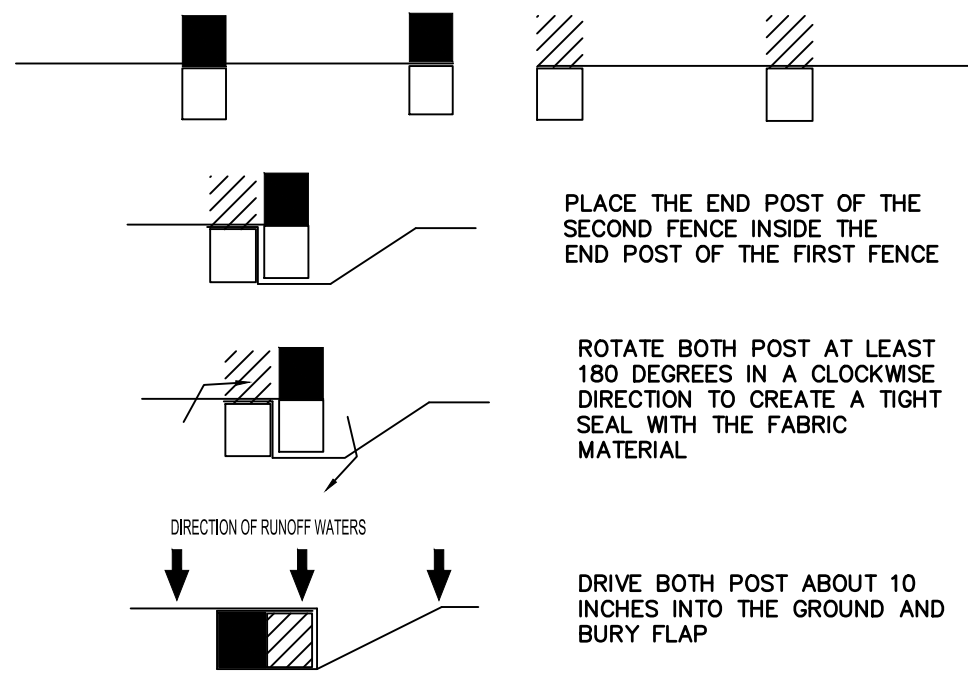


CROSS-SECTION

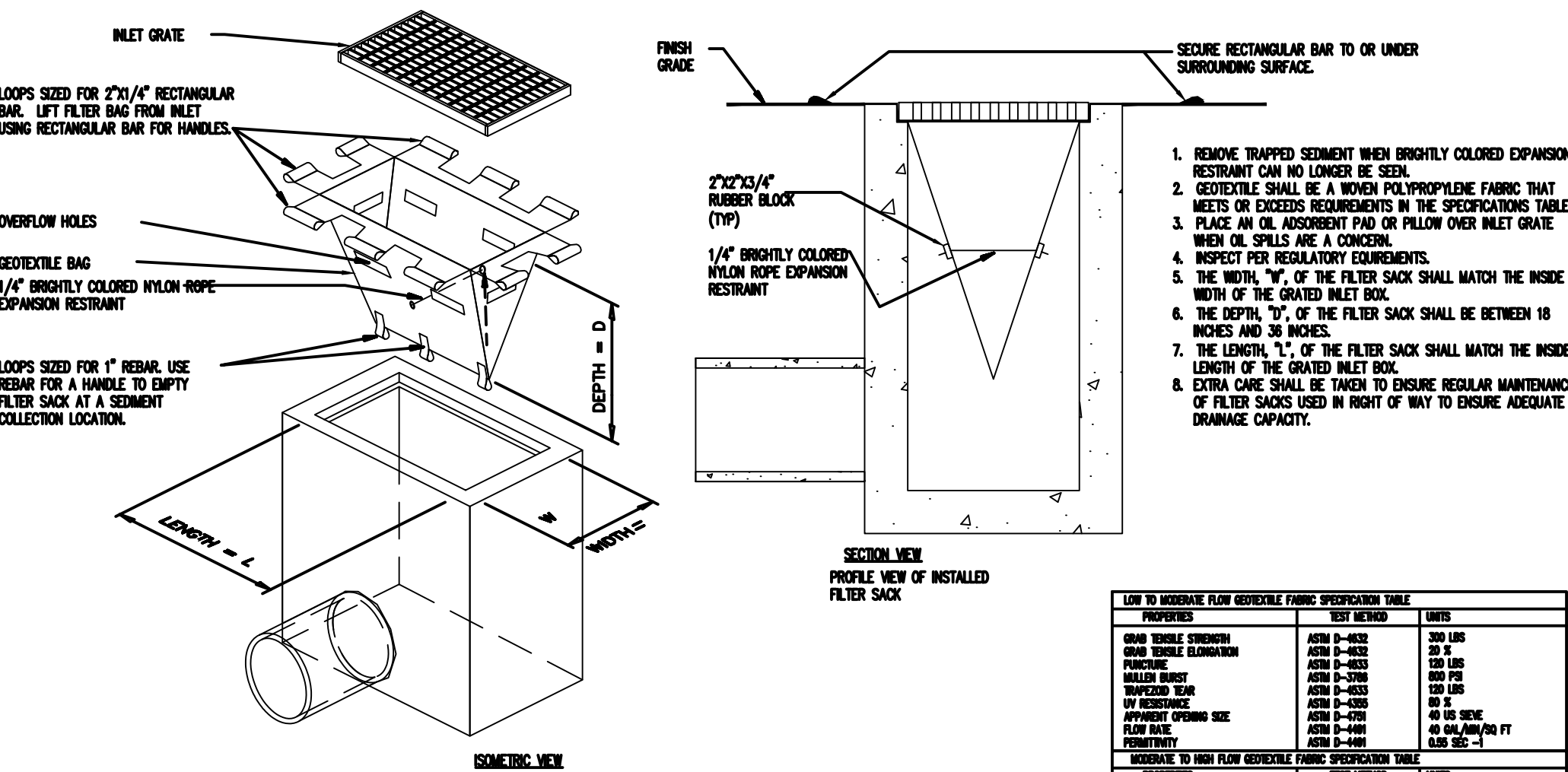
SEDIMENTATION/SILT FENCE WITH WIRE SUPPORT

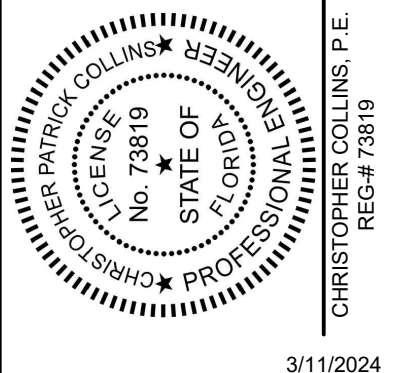
