## CITY OF POMPANO BEACH Broward County, Florida

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, ADOPTING AN ENVIRONMENTALLY SENSITIVE LANDS (ESL) MAP AMENDMENT TO REMOVE FOUR ESL DESIGNATED SITES LOCATED ON THE POMPANO BEACH AIR PARK; PROVIDING FOR A DETERMINATION THAT A LOCAL PLANNING AGENCY HEARING WAS HELD ON JANUARY 22, 2025; PROVIDING THAT A TRANSMITTAL AND ADOPTION PUBLIC HEARING WILL BE HELD; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 163.3184 F.S., the Planning and Zoning Board/Local Planning Agency held a duly noticed public hearing on January 22, 2025, on the proposed amendment to the Environmentally Sensitive Lands (ESL) Map which is part of the adopted City of Pompano Beach Comprehensive Plan, and subsequently recommended approval to the City Commission; and

**WHEREAS**, said amendment proposes to remove four areas on the ESL map located in the northwest corner of the Pompano Beach Air Park, which are legally described in Exhibit A attached hereto and made a part hereof; and

**WHEREAS**, pursuant to Section 163.3187, F.S., the City Commission held at least one duly noticed public hearing on the proposed amendment to the ESL Map which is part of the adopted City of Pompano Beach Comprehensive Plan; and

**WHEREAS,** pursuant to Section 163.3184(11)(b), F.S., this matter has been advertised at least seven days prior to the first hearing and advertised at least five days prior to the second public hearing pursuant to the requirements of Section 166.041 F.S.; and

**WHEREAS**, at the public hearings, the parties having an interest and all other citizens so desiring had an opportunity to be and were in fact heard; and

**WHEREAS**, all staff reports, minutes of meetings, findings of fact and support documents are hereby incorporated by reference; and

**WHEREAS**, the City Commission has considered the application in its entirety, staff reports, minutes of meetings, findings of fact and support documents and determines that removing these four areas is beneficial to the Airpark and the City; now, therefore,

## BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

**SECTION 1.** The foregoing application recitals, findings of fact, minutes of meetings and all staff reports and documents are true and correct, and are hereby incorporated by reference and transmitted.

**SECTION 2.** A duly noticed public hearing was held on January 22, 2025 by the Local Planning Agency in compliance with Chapter 163, F.S., to consider the referenced ESL Map Amendment.

**SECTION 3.** The City Commission hereby adopts the amendment to the ESL Map to remove the four designated areas on the Airpark.

**SECTION 4.** The Department of Development Services is directed to transmit a certified copy of this Ordinance to the Broward County Planning Council along with the City's amended ESL Map for the Planning Council to accept.

**SECTION 5.** In the event any provision or application of this Ordinance shall be held invalid, it is the legislative intent that the other provisions and applications thereof shall not be thereby affected.

<b>SECTION 6.</b> All Ordinances or parts of Ordinances in conflict herewith are to the extent
of said conflict, hereby repealed.
<b>SECTION 7.</b> This Ordinance shall take effect immediately upon its passage and adoption,
but the amendments shall not become effective until the Broward County Planning Council accepts
the amended ESL map.
