A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH SUPPORTING THE MCNAB ROAD COMPLETE STREETS IMPROVEMENT PROJECT TO BE ADMINISTERED IN COOPERATION WITH THE CITY OF FT. LAUDERDALE AND BROWARD COUNTY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Broward Metropolitan Planning Organization (MPO) approved the Broward Complete Streets Master Plan on February 14th, 2019;

WHEREAS, the McNab Road Complete Streets Improvement Project, from NW 31st Ave./SW46th Ave. to Dixie Highway has been identified as a high-ranking project in the Complete Streets Master Plan's list of recommendations;

WHEREAS, a resolution from the Pompano Beach City Commission stating support for the project is required to establish funding eligibility;

WHEREAS, the City of Pompano Beach commits to coordinate with the City of Ft. Lauderdale and Broward County to determine which Local government (Leading Agency) will administer and deliver the project under the Local Agency Program (LAP) when the project is deemed eligible for funding;

WHEREAS, the City of Pompano Beach commits to coordinate with the City of Ft. Lauderdale, Broward County and the Leading Agency, who will have to commit to fund the project design, Construction Engineering and Inspection (CEI) phases, and establish a construction contingency per the requirements of LAP before the project is programmed for funding;

WHEREAS, McNab Road Complete Streets Improvement Project, from NW 31st Ave./SW46th Ave. to Dixie Highway will be constructed within the agency's right of way;

WHEREAS, it is the responsibility of City of Pompano Beach to maintain or coordinate the maintenance of the roadways after the project's completion; and

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct, and are hereby made a part of this Resolution.

SECTION 2. The City supports this Complete Street Project, as listed on the attached Exhibit "A," to improve conditions for bicyclists and pedestrians.

SECTION 3. This Resolution shall become effective upon passage.

McNab Road	NW 31st Ave./SW46th Ave. to Dixie Highway	Separated bicycle lanes; Continuous Pedestrian Zones (Sidewalk Gaps); Lane elimination (for only the Powerline Road. to Dixie Hwy. portion) - convert to a continuous 4 lane corridor; Pedestrian lighting; Widen medians in lane elimination section; Landscaping opportunity areas, irrigation sleeves; Transit amenities & bus shelters
