In 1992, at the age of 23, I founded my first company, Voice Professional i Stockholm AB.

Today, I run four companies in Sweden and one in the United States.

The year before, at 22, I served as interim CEO for a Finnish telecom company, which I established for them in Stockholm.

Fia Hammarström – Born 1968

When I launched my own company, I quickly gained recognition in the media. I appeared on national TV talk shows, in newspapers, and on radio interviews, where I became known as **“The Girl with the Golden Voice.”**

For many years, I worked as a consultant for international corporations in the rapidly expanding voice and data technology sector. I contributed to the development of new telecom platforms and a wide range of voice applications, including elevator voice-chip integrations, synthetic voice development, voice recognition technology, and voice ID solutions for banking systems.

I was also involved in GPS guidance systems, bus and metro announcements, and the Daisy 2.02 XHTML format for the visually impaired. In addition, I developed analog and later digital frequency applications used by police departments to identify voices.

In 2009, my company underwent due diligence by a wellknown tech company, but I ultimately decided not to sell.

Over the years, my voice bank grew significantly, and I expanded into the emerging “new media” service sector with audiobook production, e-learning, and radio theatre for new audiences. I also consulted on sound format development while working creatively as a voice-over artist for leading brands, ADR productions, and dubbing.
