Horacio Danovich, Stegia LLC, introduced Nadia Locke, Chair of the Recognition Committee from Smart Growth Partnership, who congratulated the City and presented the Smart Growth Excellence award for the Pompano Beach Youth Sports Complex Park, located on the former Elks Lodge property. Ms. Locke briefly spoke about the purpose of Smart Growth Partnership, stating that their mission is to educate and advocate for the incorporation of smart growth principles into new developments and helping to create communities where people desire to live. She then recognized Kim Pearson, Former Pompano Beach Urban Forester, who is also a member of Smart Growth Partnership.

Ms. Pearson spoke about the protection and preservation of tree canopy in park facilities. She too congratulated the City on its achievement.

Ms. Locke recognized Mariann Winfield, member of the Recognition Committee from Smart Growth Partnership who was also in attendance.

#### **B. AUDIENCE TO BE HEARD**

Mayor Hardin announced that it was time for "Audience To Be Heard". The following speakers were called to speak before the Commission:

Joe Naegele, 430 SE 8th Avenue, Pompano Beach, FL, spoke about a property next door to him that seems to operate as a short-term rental. He read various definitions of motel and boardinghouses. He also reviewed the Special Magistrate fines against the property. Lastly, Mr. Naegele asked the City Commission why they cannot shut down the operation at the property.

City Manager Harrison stated the Special Magistrate operates as a separate legal body. He informed Mr. Naegele that it is not appropriate to present his questions regarding the subject property before the City Commission, rather he should present his concerns to the Special Magistrate.

City Attorney Berman stated vacation rentals are regulated by State Statute. He then offered to meet with Mr. Naegele to further discuss the Statute.

Caress Owens McGill, 305 NW 32nd Avenue, Pompano Beach, FL, spoke about human trafficking. She recommended options including press conferences, education, and creation of a task force to address the issue. Ms. Owens McGill indicated that Florida is ranked within the top 3 states in the country for human trafficking.

City Manager Harrison asked Ms. Owens McGill to connect with Mr. Bosworth to learn more about how the City is partnering with BSO to address the issue.

Sarahca Peterson, 4354 NW 9th Avenue, Pompano Beach, thanked Vice Mayor McGee for the nomination to the Public Art Committee. Ms. Peterson briefly commented on the inactivity of the Cultural Arts Committee, stating that she would like to see it revived again.

#### (Staff Contact: Jeff Lantz)

Jeff Lantz, Parking Manager, introduced the Ordinance, stating that the proposed item would allow staff to investigate technology to assist with parking enforcement. He then went on to describe the benefits of parking enforcement technology, noting that it has made great strides to assist cities nationwide. Lastly, Mr. Lantz stated that additional language will be added to the City's Code to allow the use of technology to aid parking enforcement within the city.

Mayor Hardin sought public input on the item and, receiving none, he moved on to Commission discussion.

Comr. Moss asked for further information about the technology.

City Attorney Berman said the proposed Ordinance would allow for the changes in electronic technology as it evolves. He added the code is written specifically for how a ticket is issued. The proposed Ordinance is general in nature and will prevent Mr. Lantz from returning to the City Commission frequently to ask for an amendment each time the technology changes.

Comr. Fournier said the Ordinance feels vague. She asked why they did not wait until they have a proposed system. Mr. Lantz said it is not for anything particular, but he is anticipating changing technology. Comr. Fournier stated she is worried about unintended consequences.

Mayor Hardin asked if new technology would result in savings. Mr. Lantz replied yes, it could be used in lieu of staff, if needed.

Vice Mayor McGee agreed with Comr. Fournier and would prefer it comes before the City Commission when a

specific technology is being proposed.

Comr. Perkins asked if Mr. Lantz would come before the City Commission when a new technology is decided upon. Mr. Lantz replied that he would discuss with City Management. Comr. Moss said if they passed the Ordinance, the answer is no.

Comr. Moss asked if they were giving up some of their authority. He said there are many unknowns that make him uncomfortable.

Suzette Sibble, Assistant City Manager, said it is highly likely they would return to the City Commission with information about new technology. She further stated they always let the City Commission and the public know when they are rolling out new initiatives.

City Attorney Berman stated this is just procedural should the City Commission decide to instruct staff.

Vice Mayor McGee would like to know more information about any specific technology before deciding.

Comr. Moss asked if they could rewrite the Ordinance to outline that any new technology be brought before the City Commission. City Attorney Berman replied affirmatively.

Mayor Hardin asked for clarification on the Ordinance. City Attorney Berman said the Code does not allow an issuance of a parking citation through use of electronic equipment. It must be viewed by an officer and placed on the vehicle. Mr. Berman offered to add language to the Ordinance about a review process by the City Commission.

Vice Mayor McGee reiterated she would want to know the specific technology, particularly around cameras.

Comr. Sigerson-Eaton asked when was the last time the Ordinance was amended. City Attorney Berman replied there were changes to parking but nothing to the enforcement method since he has been in office.

Comr. Sigerson-Eaton stated there are cameras everywhere; so, to be able to generate a fine or fee by electronic means is becoming more common.

Comr. Moss agreed with Comr. Sigerson-Eaton about cameras in public areas.

City Attorney Berman said he can add language to address the concerns.

#### 14. 24-55 P.H. 2024-15: (PUBLIC HEARING 1ST READING)

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, AMENDING CHAPTER 34, "CITY POLICY," OF THE CITY OF POMPANO BEACH CODE OF ORDINANCES BY CREATING SECTION 34.009, "CITY'S LOGO," TO PROVIDE RESTRICTIONS ON USAGE OF THE CITY'S DESIGN MARK (LOGO) OR WORD MARK; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

(Fiscal Impact: N/A)

#### (Staff Contact: Mark E. Berman)

City Attorney Berman introduced the item and highlighted the main points of the Ordinance, which are as follows:

- (A) No one other than city officials and staff may utilize any adopted City Design Mark (Logo) or Word Mark for any purpose unless such has first been authorized by the City Commission or its designee.
- (B) No adopted City Design Mark (Logo) or Work Mark may be utilized on any products, goods or services offered or which may be offered for sale, resale or other commercial use, unless approval for same has first been obtained from the City Commission or its designee.
- (C) No adopted City Design Mark (Logo) or Word Mark may be utilized by any candidate for election or re-election to any city or other elected office on or as part of their election campaign materials, other than as depicted in photographs of city officials taken during the course of performance of their official duties.

Lastly, Mr. Berman said he worked to capture in the Ordinance previous matters that caused issues in the past, nonetheless he is willing to make any modifications as the City Commission sees fit.

Mayor Hardin sought public input on the item and, receiving none, he moved on to Commission discussion.

Mayor Hardin expressed appreciation for the item and he thanked Mr. Berman for keeping the Ordinance broad in scope and not narrowing it down to more than what was intended.

Comr. Fournier inquired about enforcing the Ordinance and whether, upon termination, city employees returned uniforms and other items containing the City's logo. She also asked what would happen if the items are given to Goodwill. City Attorney Berman responded, stating that he believes departments take back those items upon termination. With regard to enforcement, he did not add provisions of Section 10.99 to the Ordinance as the violations are not punishable by arrest or fines. He then outlined enforcement methods for violations of the Ordinance by employees, private companies, or elected officials. He noted the logo has been trademarked and is protected pursuant to Federal law.

Comr. Fournier asked if they are creating a situation where a designee has to approve the City logo on

everything. City Attorney Berman replied, stating that the intent of the Ordinance is to ensure the City's logo is being used appropriately and not used in the stream of commerce nor for one's personal advantage. In sum, Comr. Fournier expressed that she is not in favor of passing this Ordinance as it has no enforcement provisions and can have many interpretations.

Vice Mayor McGee asked if there is a definition in the Code of what constitutes use of the logo. City Attorney Berman said yes.

Mayor Hardin stated that, "Florida Warmest Welcome" is trademark protected along with the City's Service Mark. They are both protected by Federal copyright laws.

motion McGee, seconded A was made by Vice Mayor by Commissioner Sigerson-Eaton, that the Ordinance / Regular Agenda **APPROVED FIRST** READING. The motion carried the following roll call vote:





### **Alternative Assessment Considerations**

- Revenue impacts Changing the assessment could result in increased revenues but it depends on the type of development
- Impacts on fees paid by new development <u>Commercial</u> development would more than likely have increased fees while multi-family development could have decreased fees.
- Administrative burdens This approach requires more upfront information to calculate the fee, and monitoring, as you would have to audit accounts after a year to "true-up" the fee. This would require additional staffing to monitor usage, make annual adjustments, and developer tracking, all of which would be paid for by any gains from changing methodology.
