BE IT RESOLVED BY THE POMPANO BEACH COMMUNITY REDEVELOPMENT AGENCY THAT:

SECTION 1. The Property described on Exhibit A shall be transferred to the City of Pompano Beach.

SECTION 2. The proper officials are hereby authorized to execute the warranty deed needed to accomplish the transfer.

SECTION 3. This Resolution shall become effective upon passage.
