BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That a Subrecipient Agreement between the City of Pompano Beach and Experience Aviation, Inc., funding, on a reimbursable and limited basis, a Pre-Apprenticeship & Workforce Development STEM Program in the maximum amount of \$200,000.00, is approved, and a copy of the Subrecipient Agreement is attached and incorporated by reference as if set forth in full.

SECTION 2. That the proper City officials are authorized to execute the Subrecipient Agreement between the City of Pompano Beach and Experience Aviation, Inc.

SECTION 3. This Resolution shall become effective upon passage.
