This General Release shall further cover any and all claims arising out of said incident including, but not limited to, funeral expenses, medical bills, medication, hospital expenses, past, present and future, hospital and doctors' liens, insurance liens, workers' compensation liens, attorneys' fees or liens, costs, and any and all other insurer's claims, subrogated interests or liens.
