LEGAL DESCRIPTION (ALLEY ABANDONMENT)

AN ALLEY, PUBLICLY DEDICATED RIGHT-OF-WAY, WITHIN BLOCK 2, AS SHOWN ON THE PLAT OF CAMPBELL AND SAXON ADDITION, RECORDED IN PLAT BOOK 1, PAGE 125, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

ALL OF THE ALLEY IN BLOCK 2, CAMPBELL AND SAXON ADDITION PLAT, AS RECORDED IN PLAT BOOK 1, PAGE 125, LYING SOUTH OF LOTS 1-5, ALL INCLUSIVE, WITHIN BLOCK 2, OF SAID PLAT, AND LYING NORTH OF LOTS 6-10, ALL INCLUSIVE, WITHIN BLOCK 2, BEING BONDED ON THE EAST BY THE WEST RIGHT-OF-WAY LINE OF NORTHEAST 3RD AVENUE, AND ON THE WEST BY THE EAST RIGHT-OF-WAY LINE OF NORTHEAST SECOND AVENUE.

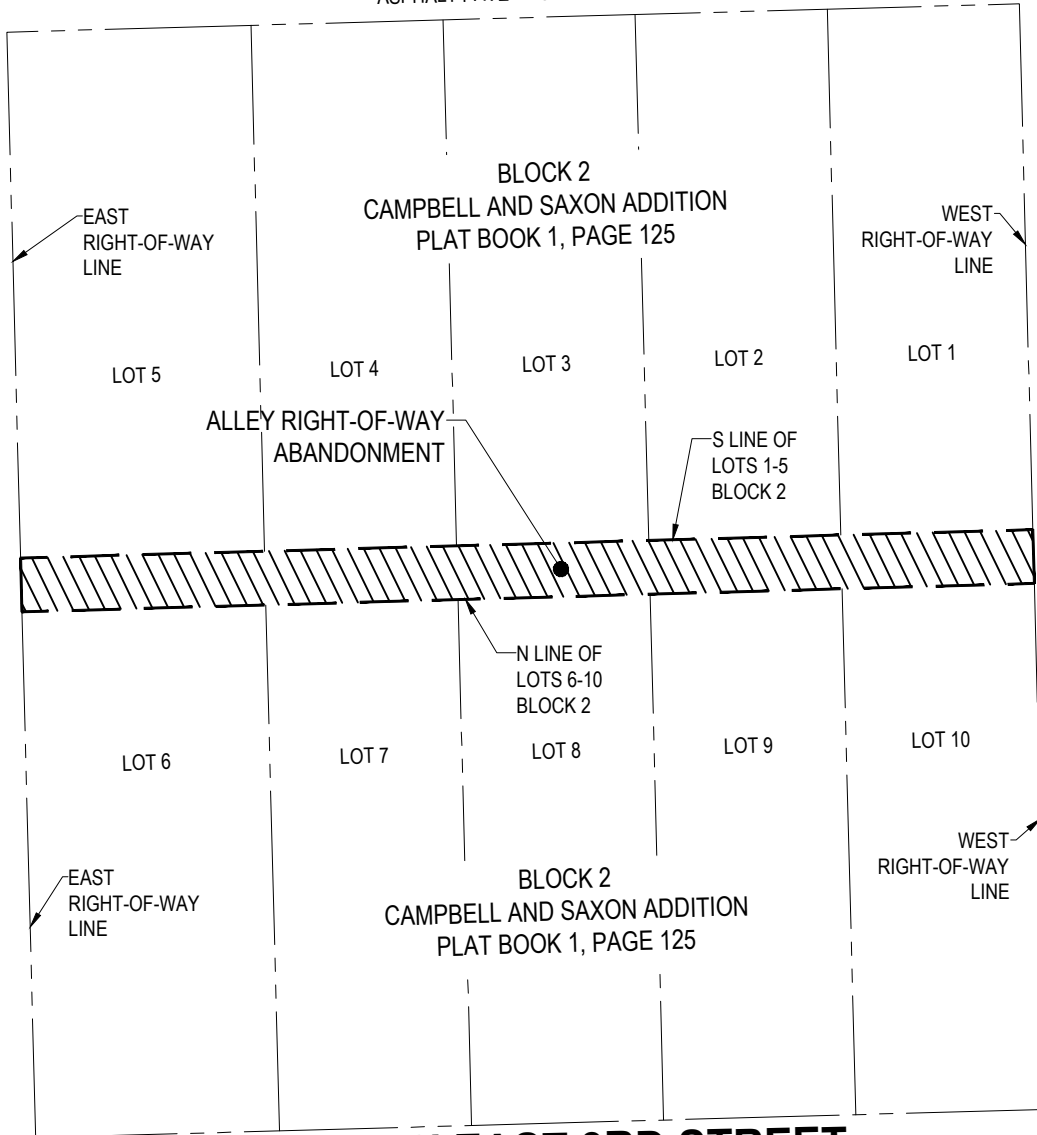

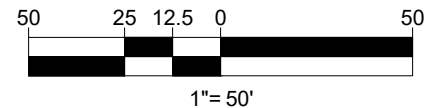
