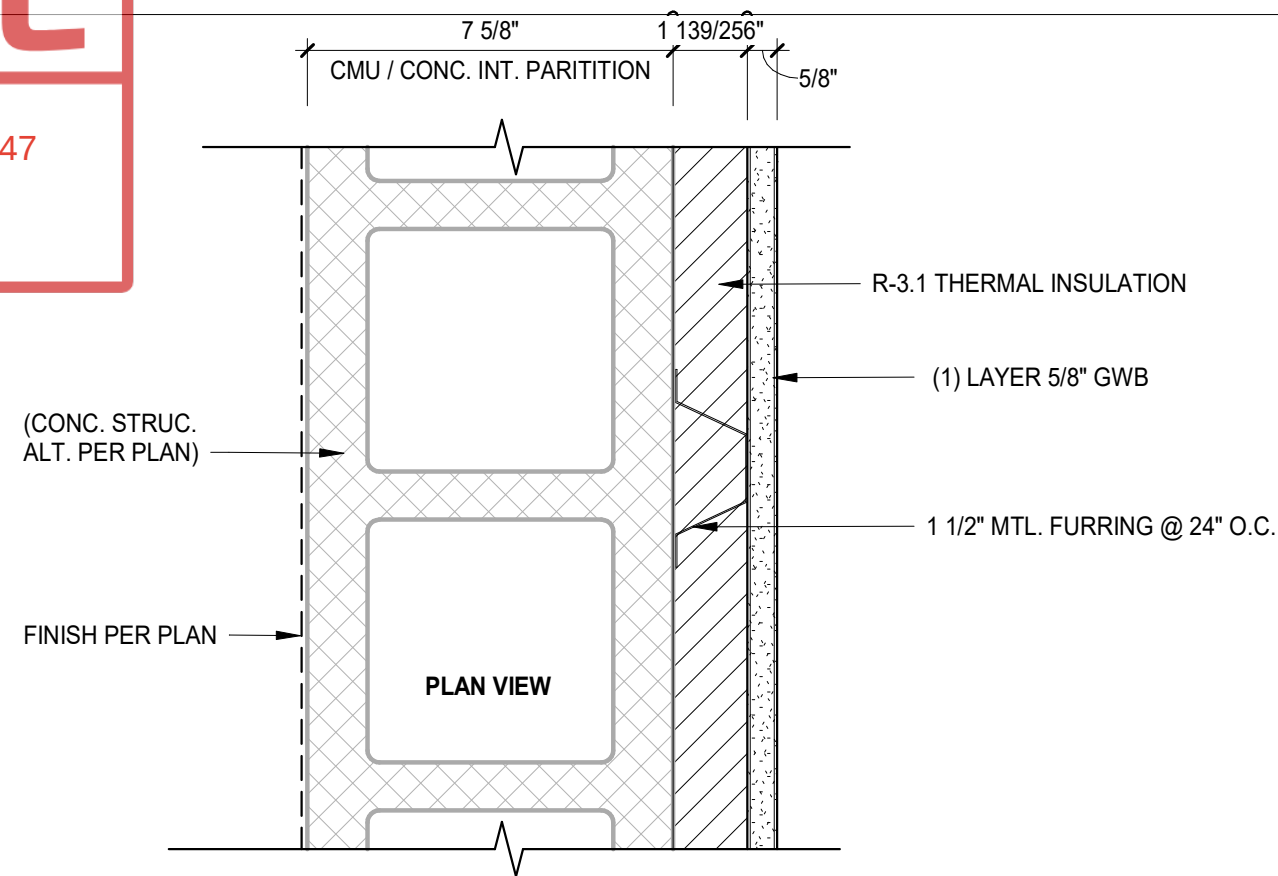
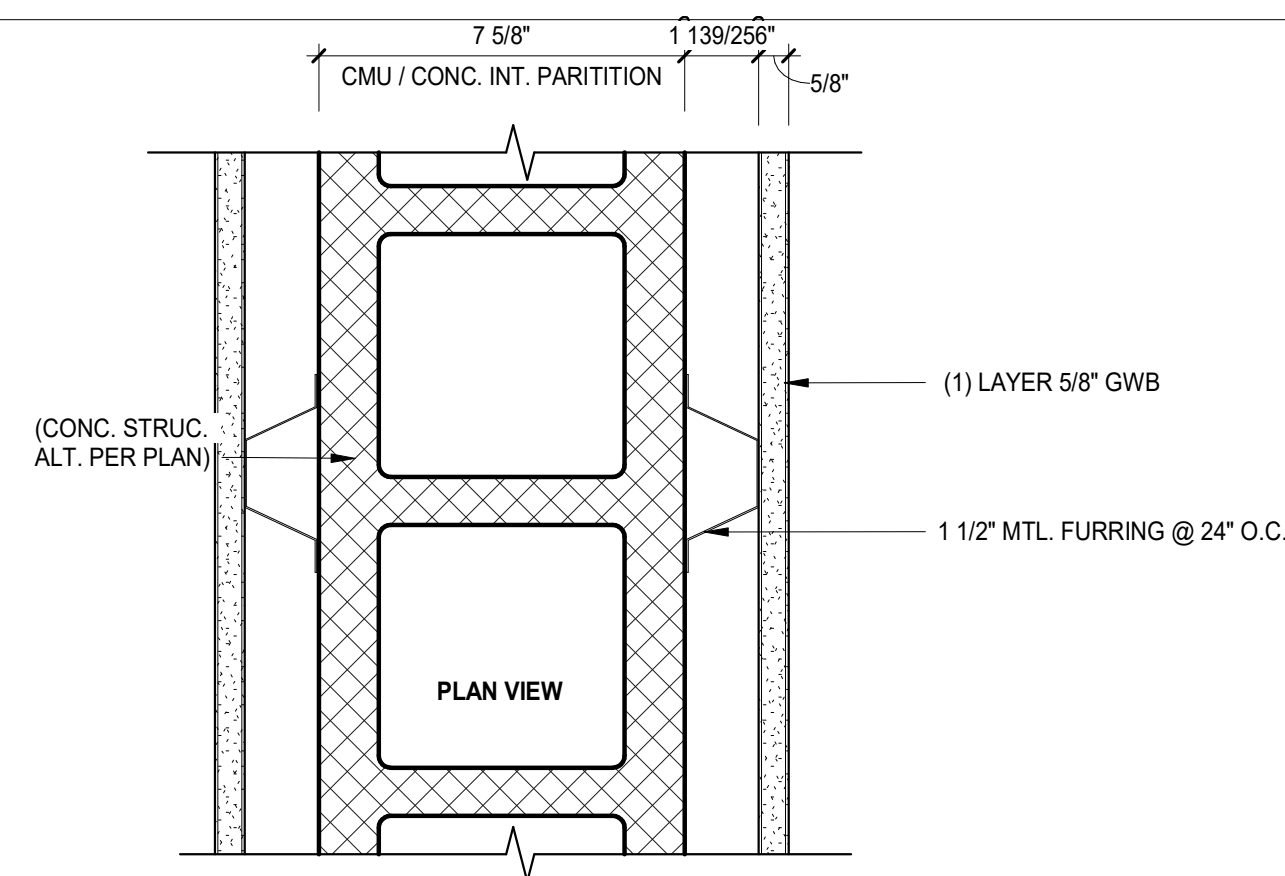




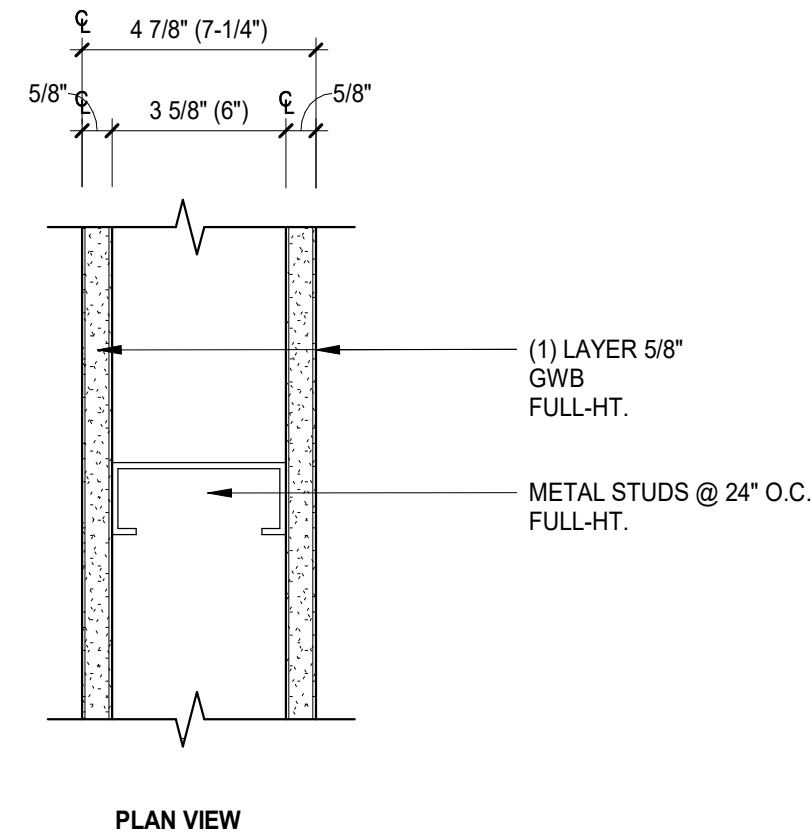

P 1 8" CMU/CONC. - 1 1/2" MTL.FURRED GWB



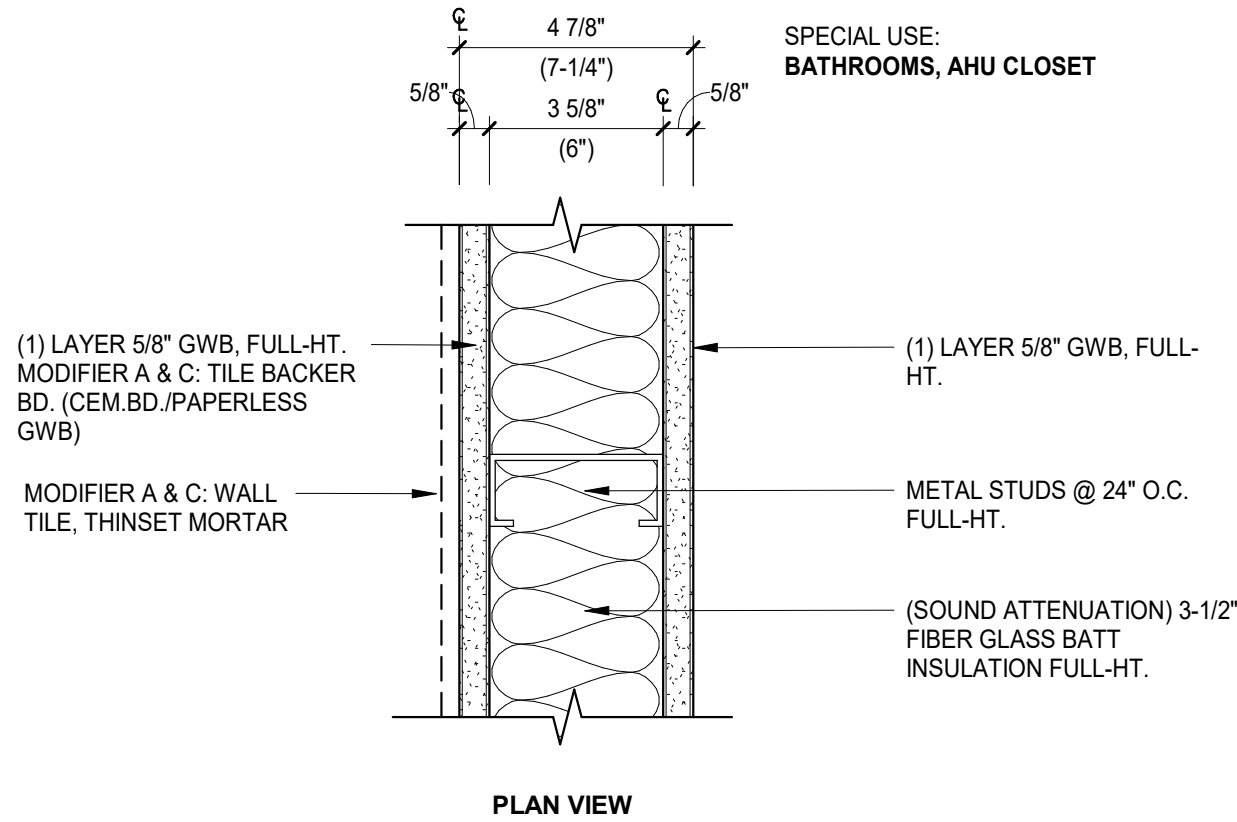
