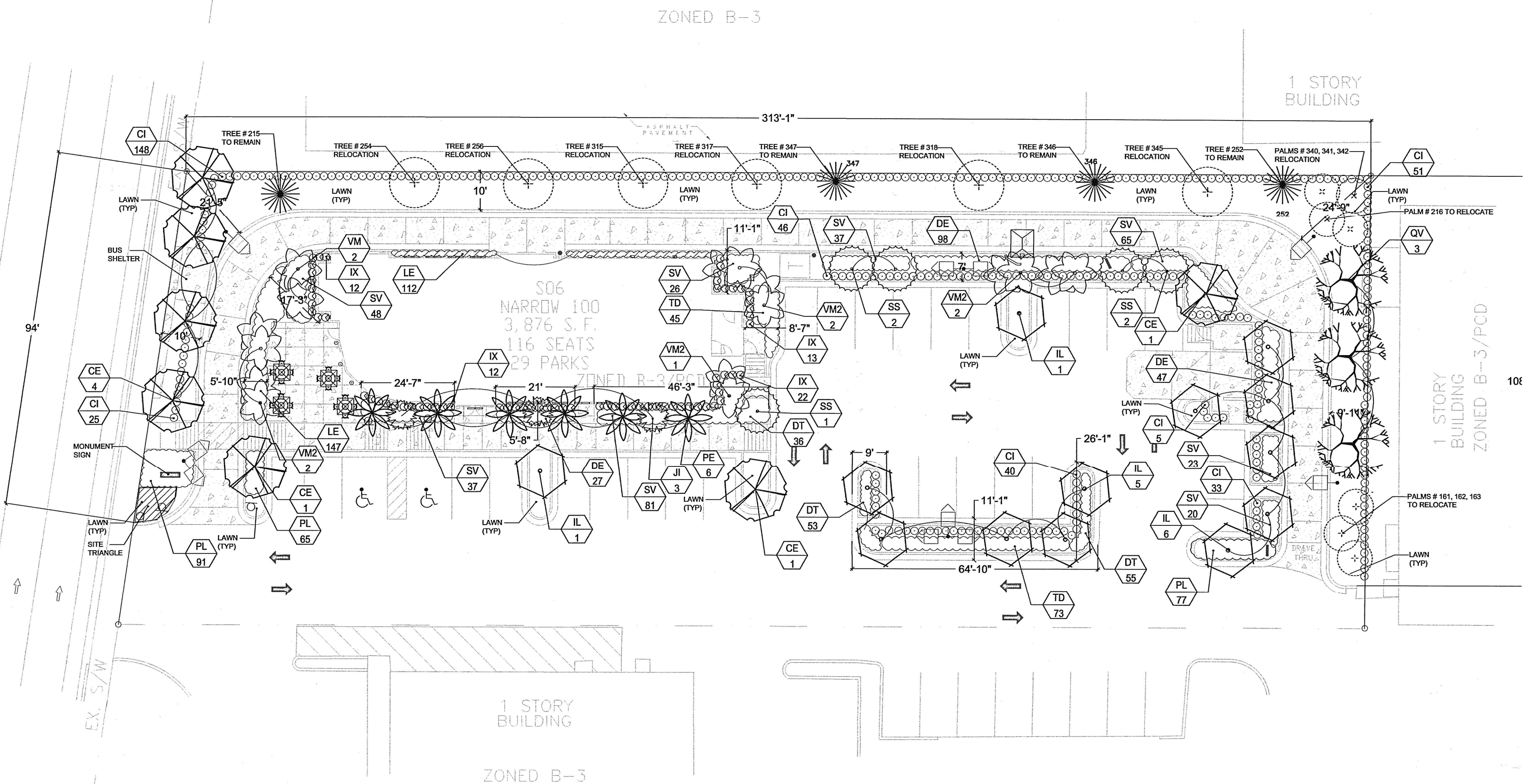


U.S. HIGHWAY N

LOT REQUIREMENTS: (1) TREE AND (5) SHRUBS PER 3000 S. F. OF PERVIOUS AREA.

STREET TREE REQUIREMENTS: (1) TREE PER 40 L. F. AND A CONTINUOUS 24" HIGH HEDGE

SOD AND IRRIGATION TO BE PROVIDED IN SWALE AREA.
TREES SHALL NOT BE PLANTED WITHIN 15' FROM LIGHT POLE LOCATIONS.
