## 2018 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT APPLICATION BJA-2018-13626 PROJECT ABSTRACT

The city of Pompano Beach, Florida will accept Edward Byrne Memorial Justice Assistance Grant (JAG) funding on behalf the seventeen (17) sub-recipients in the amount of \$493,448.00, which is \$22,431.00 less than the original allocation from the Department of Justice, Office of Justice Programs. Broward County did not provide a project as they believe if they receive JAG Direct funding would jeopardize them losing their award from Florida Department of Law Enforcement (FDLE). Pompano Beach will be lead agency for JAG handling fiscal and programmatic oversight.

Located just north of Fort Lauderdale, in the heart of Florida's Gold Coast, the City of Pompano Beach is home to some of the warmest and clearest waters, welcoming golden fine sandy beaches and calming breezes. The city's name was derived from the Florida pompano which was a fish found off the Atlantic coast and often the eaten at dinner time of most settlers, in the late 1800's. As the city developed led by railroad expansions the community increased during the Florida land boom of the 1920s. The population boom due to World War II, in 1947, the city of Pompano merged with the newly formed municipality on the beach and became the city of Pompano Beach.

Census in 1910, was 269 and estimated in 2016 at 109,393, as Pompano Beach like most cities in southeast Florida, was invaded by people moving to the city, to flee winters in northern parts of the United States. The median income for a household in the city is \$42,641 and is estimated that 21.2% of the populations is below the poverty line. Ultimately the city works comprehensively and systematically to improve services, activities and management processes that meets what Pompano residents want from the city.

In its strategic plan Pompano Beach seeks to be a preferred place to live; conduct business; grow through quality, sustainable development; provide quality and affordable city services and build confidence in city government. Top priority is given to capital improvements and beautification programs which is impacted by the city's homeless population. Pompano Beach like many cities nationwide have challenges often discussed during commission meetings to address issues hindering revitalization of the city's infrastructure that includes: neighborhoods, parks, beach, school and businesses.

Many stakeholders work collaboratively on the strategic plan to ensure the city's investments are maintained which consists of: Parks and Recreation Division, Finance,

Public Works, Utilities and Development Services, Broward Sheriff's Office, Fire/Rescue and City Commissioners. Edward Byrne Memorial Justice Assistance Grant funds are value added to the city of Pompano Beach as they aid in our ability to provide intervention, prevention and protection to city residents and visitors. JAG funding will also allow subrecipients to implement their projects as follows: (brief synopsis)

<u>Coral Springs Police Department</u> was allocated \$14,039 for Equipment. Simunition Conversion Kits will be purchased with JAG funding to be used for scenario based training for all officers.

<u>Davie Police Department</u> was allocated \$15,912 to purchase a computer and associated hardware/software for its Mobile Command Vehicle and Communication Unit.

<u>Fort Lauderdale Police</u> was allocated \$81,675 for three projects. Project 1: Evidence Warehouse Security- to update its cameras and monitor the facility in preservation of evidence stored. Project 2: Traffic Safety & Public Notification Project- to improve the traffic safety environment for bicyclists, motorists, and pedestrians resulting in preservation of life and property damage. Project 3: Forensic Evidence Efficiency Improvements- to reduce inefficiencies in latent photography and print examination

<u>Hallandale Beach Police Department</u> was allocated \$15,096 to purchase small equipment and technology to enhance proactive policing efforts towards combatting crime in the city.

<u>Hollywood Police Department</u> was allocated \$43,041 to purchase a fixed License Plate Reader for rapid dissemination of information pertaining to criminal intelligence, photos, tags and felonious vehicle information in real time.

<u>Lauderhill Police Department</u> was allocated \$37,289 to purchase ballistic shooter kit that will prepare officers in the event of an active shooter which includes protective wear: harness, helmets and rifle plate.

<u>Miramar Police Department</u> was allocated \$28,980 to purchase a mobile license plate reader to identify subjects of interest and enhance crime prevention strategies.

<u>Pembroke Pines Police Department</u> was allocated \$21,796 to purchase license plate reading hardware & software package system. This equipment will enhance the department's and increase officer/detectives' ability to locate and identify motor vehicles that have flagged license plate information.

<u>Plantation Police Department</u> was allocated \$17,696 to upgrade existing technology to maintain pace with criminals and deter crime.

<u>Sunrise Police Department</u> was allocated \$17,036 to fund overtime for community oriented policing operations to strengthen community partnerships and address neighborhood problems.

The following is a list of projects in cities that contract with BSO for law enforcement services.

### **Broward County: DID NOT SUBMIT A PROJECT FOR CONSIDERATION**

<u>BSO-Dania Beach District</u>: \$11,526 of the award will pay for overtime to conduct surveillance to reduce their high rate of auto theft and to introduce the Juvenile Offender Prevention Initiative. The Juvenile Offender program will assign detectives to visit juvenile offenders and probationers' residences to monitor their activities, interact with them and their guardian(s). Dania will utilize the Crime Analyst to provide Hot-Spot Mapping, Pin-Point Mapping, and analysis of criminal incident reports.

<u>BSO-Deerfield Beach District</u>: \$21,619 of the award will pay overtime to deputies to conduct surveillance of targeted shopping centers that have an increased amount of aggravated assaults and robberies.

BSO-Lauderdale Lakes District: \$17,477 of the award will pay for overtime expenses related to Crime Reduction Operations as based on a comprehensive analysis that shows an increase in burglaries and robberies in the city. Support will be needed from the Crime Analyst to identify real-time data and the location of criminal offenses.

BSO-North Lauderdale District: \$14,039 of the award will be used for overtime expenses to conduct surveillance in targeted areas, as well as for the Crime Analyst data support. Overtime will be paid to increase patrol activities to prevent juvenile involvement in crime and truancy, to reduce Auto Theft and Juvenile Offenses. The Crime Analyst will provide the city with local intelligence, mapping and review incident reports to identify crime trends.

BSO-Oakland Park District: \$15,162 of the award will be used to increase community interaction at the city's parks and recreation facilities and deter youth from criminal activity by creating a juvenile offender program. The program will target youth that are on probation and collaborate with

stakeholders and parents to monitor the youth's activities. Police will interact with the youth, and their guardians to prevent future criminal behavior, and link families to social services or appropriate intervention. Also, overtime on all shifts will increase patrol to reduce auto thefts, burglaries and community crime prevention.

BSO-Pompano Beach District: \$109,708 of the award will be used for Homeless Outreach and support from the Regional Crime Analyst. Deputies will engage homeless individuals to assist with transition to shelters, collaborate with community resources and combat crime committed by homeless individuals. This program is designed to identify at-risk populations and offer needs-based assessment to homeless individuals and families to reduce recidivism. Pompano Beach will also be the lead agency and provide fiscal and programmatic oversight.

<u>BSO-Tamarac District:</u> \$11,349 of the award will be used to reduce property crimes, auto theft, both residential and auto burglaries as funding allows officers to work overtime to conduct surveillance of high crime areas and to monitor known juvenile offender activity.

#### **GOALS:**

- 1. Provide crisis interdiction to reduce chronic homelessness for individuals, veterans and families
- 2. Connect eligible homeless individuals and families with social and health services
- 3. Increase awareness and connectivity with the community on crime problems and to partner with local businesses, homeowners, veterans, religious institutions, homeless coalitions, and nonprofit organizations
- 4. Provide de-escalation training to sworn personnel and promote de-escalation as an important strategy to diffuse potentially volatile situations

#### **OBJECTIVES:**

### Goal 1: Provide crisis interdiction to reduce chronic homelessness for individuals, veterans and families

- Deputies will identify risk and protective factors to prevent episodes of homelessness for at-risk populations in the City of Pompano Beach.
- Deputies will identify military veterans that are homeless and in need of housing, government services and benefits.
- Deputies will provide, disseminate, and promote the use of evidence-based homelessness prevention and early intervention programs and strategies.
- The deputy will increase positive reinforcement (verbal recognition of positive behavior) and ensure that best policing practices are exercised.

### Goal 2: Connect eligible homeless individuals and families with social and health services

- Deputies will interact with individuals that are experiencing homelessness, provide and inform them of the services that are available to help improve their Quality of Life.
- Services to be provided will include but not limited to shelter, health care, detox facilities, housing, psychological services, food, transportation and reunification to family members.
- The deputies will build trust, rapport and empathy within the homeless community.
- Deputies will continue their partnership with the Homeless Coalition at a minimum of once a week.
- Literature will be provided in the form of a pocket card called the, "Homeless Survival Guide." The guide will explain where to receive social service benefits and what transportation methods are available to them.

Goal 3: Increase awareness and connectivity with the community on crime problems and to partner with local businesses, homeowners, veterans, religious institutions, homeless coalitions, and nonprofit organizations

- Deputies will be working closely with businesses and homeowner associations providing them with information regarding the homeless. This partnership brings an understanding of the needs and problems associated with homelessness so they can work together to improve the community and provide the homeless the help they need.
- The Broward Sheriff's Office Pompano Beach District Homeless Outreach Team (HOT) has established partnerships with the City of Pompano Beach, local homeless coalitions, the Broward Outreach Center, St. Laurence Chapel, local churches, business owners, homeowners associations, nonprofit organizations and veterans groups and will continue to support these partnerships.
- The Broward Sheriff's Office Pompano Beach District Homeless Outreach Team deputies will continue to develop strategies to track crime and the homeless population and assess their needs on a regular basis to ensure the best policing practices are exercised.
- The grant funds will be utilized by having additional deputies that will be specifically assigned to only Homeless Outreach tasks releasing them from traditional Law Enforcement duties. These deputies will make a difference in the homeless community by their continued presence, compassion for the unfortunate and implementation of programs and educational tools that will address their immediate needs. This assistance will not only enhance their quality of life but also assist to break the homeless cycle and reduce the chances of the homeless becoming a victim of a crime.
- The Deputies will also encourage business and community members to get involved in creating a safer environment and eliminating the fear of homelessness and victimization of the less fortunate. The Deputies along with our community partners have implemented a system of programs designed to educate the community and will continue providing literature to all involved. This will help in teaching the members of the community that living in and maintaining a safe community is vital and that their contributions are necessary.

### Goal 4: Provide de-escalation training to sworn personnel and promote de-escalation as an important strategy to diffuse potentially volatile situations

A hallmark of our Crisis Intervention Team (CIT) class is instruction in de-escalation techniques to
diffuse potentially volatile situations. This instruction teaches the deputy to lessen confrontation
by communicating appropriately. This skill is used with all homeless encounters. Since a
significant portion of the homeless population in the City of Pompano Beach have some form of

mental illness, deputies trained in de-escalation techniques have the skills to bring a mutually successful end to any encounter. The deputies will also increase their knowledge and skills as they relate to mental illness and substance abuse during class instruction.

- The Homeless Outreach Team (HOT) training class curriculum includes instruction in strategies for non-confrontational encounters and rapport building by means of de-escalation, with individuals experiencing homelessness. The Broward Sheriff's Office Pompano Beach District Homeless Outreach Team Specialists will serve as the district's liaisons to the homeless community. The deputies will be involved in, but not limited to, activities related to addressing the homeless population in the City of Pompano Beach, the social services community, and the continuum of care. The deputies on overtime will conduct regular follow-up assessments on individuals experiencing homelessness to ensure that their needs are met along with the community's needs.
- As HOT deputies complete their mandated training, the skills they learned will lead to successful
  non-confrontational interaction with the homeless, building trust between the deputy and the
  homeless individual. Once this trust is established it leads to program acceptance, shelter
  enrollment and ultimately reduces the cycle of homelessness and possible victimization.

#### **PROJECT IDENTIFIERS:**

### Community Based Programs

In the City of Pompano Beach there are numerous community based programs to assist law enforcement with homelessness. Some of these outreach programs provide not only basis needs such as food, clothing, personnal hygine but also job training and placement. Others provide mental health care along with faith based programs.

### Community Policing

Deputies will continue to reach out, not only to local businesses but also homeowners, and religious institutions and ask for their spirit of coorporation in working to address the homeless population.

#### Crime Prevention

Numerous times deputies have come in contact with homeless individuals that have become victim(s) of crimes. Homeless outreach deputies have gardnered a level of trust from the homeless population

which inturn gives the individual a comfort level to report the crime to the deputy. This level of trust has afforded the homeless to reach out to deputies providing perinant information on unsolved crimes.

### **PROGRAM NARRATIVE:**

### **DESCRIPTION OF THE ISSUE**

A homeless person is an individual without permanent housing who may live on the streets; stay in a shelter, mission, single room occupancy facilities, abandoned building or vehicle; or in any other unstable or non-permanent situation. (National Health Care for the Homeless Council, 2017).

The cause of homelessness stems from a myriad of challenges including, but not limited to, a loss of employment; lack of affordable housing; health problems; medical problems; mental illness; substance abuse; domestic or family issues; evictions; economy; and, gambling.

With more than 2,318 homeless individuals in Broward County (2018 Point-in-Time Homeless Count), nearly half of them are in or transient through the City of Pompano Beach. The homeless population in Pompano Beach has increased drastically with the closings of two homeless shelters located within Broward County and adjacent to the City of Pompano Beach. This population also fluctuates seasonally, swelling during the winter months. The City of Pompano Beach also has a significant homeless population that are US military veterans. These veterans are eligible for services thru the VA. Deputies are the catalyst that connects both the veterans and the VA.

The local Broward Outreach shelter in the City of Pompano Beach has only 239 beds. These beds are not enough to house all of the homeless overnight. This has greatly overwhelmed the City of Pompano Beach's law enforcement services and ultimately has resulted in more arrests than what could be offered in services through a solutions-based initiative. In fact, more homeless individuals and families are in far worse condition than their initial crisis; this has served as a catalyst toward chronic homelessness (Broward County Outreach, 2013). The homeless population has also had an impact on the quality of life of not just those who are affected by homelessness, but also by the people who are the neighbors of those same homeless individuals.

In 2017, the Broward Sheriff's Office Pompano Beach District handled 3275 calls for service involving the homeless, of which 1,314 of the calls were at homeless shelters. Examples of the calls for service include

but are not limited to the following: 2 Shootings, 1 Stabbing, 7 robberies, 7 suicides/attempted suicides, 38 mentally ill persons, 4 sexual assaults, 11 lewd and lascivious, 52 assaults, 588 Trespassers, 61 medical calls, 830 disturbances, 3 death investigations, and 539 suspicious incidents/persons. This is an obvious strain on public safety resources here in the City of Pompano Beach. Moreover, police agencies from around Broward County and local hospitals send the most unfortunate to the homeless shelter which is housed in Pompano Beach. However, this facility is at capacity daily with a waiting list. Oftentimes, these individuals are released on site with no means of support or assistance.

### PROJECT DESIGN AND IMPLEMENTATION

In 2015 the Broward Sheriff's Office Pompano Beach District initiated a Homeless Outreach Team (HOT). The team's main objective is to provide direct outreach services to the homeless in order to reduce the prevalence and duration of homelessness in Pompano Beach. These deputies are able to connect with people experiencing homelessness to provide and inform them of the services that are available and to help improve their Quality of Life. They provide a continuum of care that will allow a person to break the homeless cycle and reduce the chances of becoming a victim of violent or non-violent crime. The services that are offered include shelter, health care, detox facilities, housing, and reunification to family members. The Homeless Outreach Team currently consists of two sworn deputies that work in this capacity on a full time basis allowing them to build trust, rapport and empathy within the homeless community. This trust allows the HOT deputies to gather information on street crimes, as well as direct people towards services they desperately need.

Additionally, the HOT deputies work closely with businesses and homeowner associations providing them with information regarding the homeless. This partnership brings an understanding of the needs and problems associated with homelessness so they can work together to improve the community and provide the homeless the help they need. Partnering with BSO is the City of Pompano Beach, Florida Department of Children and Families, Broward Partnership for the Homeless, Broward Housing Solutions, Florida Department of Transportation, Florida Coalition for the Homeless, Broward Crime Commission, Broward 211, St. Laurence Chapel, Pompano Homeless Coalition, Community Action Team and Calvin, Giordano Code Compliance.

### **CAPABILITIES AND COMPETENCIES**

Currently, the homeless population in the City of Pompano Beach is estimated to be approximately 550 persons. This population also fluctuates seasonally, swelling during the winter months. The 2018 COPS Hiring Grant funds would be used to fund deputies that will augment the HOT Team and more effectively address the homeless population within the City of Pompano Beach.

Because of the population and diversity of the City of Pompano Beach and its uniqueness (Beach area resorts, urban and industrial locales), the awarded grant funds will be utilized for deputies in an overtime capacity to work with the homeless population. The homeless outreach deputies' responsibilities will be directed at reaching out and addressing their immediate needs. They will also take a more proactive approach in coordinating with all our community partners to assertively involve these groups in our homeless outreach and identified crime problems. Our focus will be geared toward more effective outreach in the locations and corridors that have experienced increased homeless populations and the crime associated with them. We will continue with our communications between the homeless population, the community and our outreach deputies. This continued assistance will not only enhance the quality of life but also assist to break the homeless cycle and reduce the chances of someone becoming a victim of a crime.

Homeless Outreach Deputies will also be provided the most advanced technology available to ensure prompt response time, analysis of data and information, crime reporting accuracy and communication procedures to enhance agency transparency. The homeless outreach deputies will utilize innovative approaches that produce positive results to ensure the reduction of crime and increase the safety for the homeless and the community as well.

### PROJECT ABSTRACT:

This project will be to enhance the Pembroke Pines Police Department's License Plate Reader (LPR) program through the procurement of additional hardware and licensing for the deployment of a fixed License Plate Reading system. This equipment will be deployed within the jurisdiction of Pembroke Pines which has an estimated population of 168,587 (2016 estimate), located in Broward County, Florida. The goals and objectives of the project are measureable, in particular with the expenditure of funds, number of units to benefit/make use of the equipment, and the number of vehicle license plates that will be checked within a fixed period of time (quarterly basis). The

City anticipates the following approximate programmatic timeline for this project:

- 1. January June 2019. Fully executed applicable certifications and/or Memorandum of Understanding or agreements
- 2. July December 2019. Procurement and installation of equipment, and training provided to relevant personnel.
- 3. January March 2020. Full deployment of the LPR system and conclusion of grant activities and closeout.

### PROGRAM NARRATIVE:

### Description of the issue

Advancing technology continues to bring law enforcement enhancements to traditional investigative methods and techniques, as well as to further improve upon their scope and efficacy across a variety of specialty areas. One of these recent emergent technologies that has been shown to be extraordinarily useful with aiding law enforcement in the timely recovery of stolen vehicles, location of missing persons, and identifying suspects involved in crimes involving known vehicles of interest—has been license plate reader (LPR) systems. This technology makes use of automated plate recognition equipment and software to identify flagged license plate information in a national/state/local database. The Pembroke Pines Police Department has successfully made use of an LPR program since June 2014. Our Burglary Suppression Team currently deploys (4) mobile LPR systems on marked/unmarked units along with nine (9) LPR trailers which are monitored by assigned LPR operators.

The capability of LPR systems to rapidly scan high volumes of vehicle tags in the field and return results makes them extremely effective in quickly identifying vehicles that have flagged license plate information. Moreover, because flagged license plate information is shared across a national/state/local database, deployed LPR systems offer a regional enhancement in aiding law enforcement personnel who are searching for known vehicles of interest across a variety of investigative types.

### Project Design and Implementation

The LPR under this proposal will be a fixed platform consisting of two (2) cameras. The equipment will be installed on a pre-existing Red Light Camera pole, for which the City of Pembroke Pines utilizes as part of its Red Light Camera program—this configuration will allow for ease of installation and use of pre-existing power & communication/network lines. The location is adjacent to the Colony-Point retirement community, an adult (55+) gated condominium community comprising more than a hundred units. The fixed LPR system will capture a high volume of traffic on the roadway and will run on a 24/7 operational basis.

### Capabilities and Competencies

The project will be managed administratively (grant financial and programmatic performance) by the Police Department's Project's and Research Manager. Procurement, installation, and deployment of the equipment will be overseen by the Police Department's LPR Unit Supervisor (Detective Sergeant) and the designated LPR Specialist (Police Service Aide).

Relevant data will be collected to allow for the reporting the three (3) listed performance measures outlined in the OBJECTIVES topic area. Data is collectable directly from the equipment that will be utilized, and the number of trained personnel who will use it. This can be reported on quarterly basis to demonstrate ongoing usage of the equipment to assess performance on a continual basis.

# PROJECT ABSTRACT:

The Broward County Sheriff's Office Dania Beach District will utilize awarded JAG Funds for overtime expenses related to a conveyance and business burglary prevention initiative. These funds will allow the Dania Beach District to conduct plainclothes and

unmarked surveillance in locations that are experiencing an increase in the above crimes. These locations will be identified through our regional crime analyst who will provide current data regarding times, dates and location of crimes. Deputies and Detectives will be deployed in these areas in an attempt to apprehend suspects who are responsible for committing these offenses. Deputies and Detectives will also meet with business owners throughout Dania Beach and conduct CPTED (Crime Prevention Through Environmental Design) surveys. These surveys will assist in identifying ways to improve the security of facilities and parking lots.

## **PROJECT NARRATIVE:**

Currently, the City of Dania Beach is the home to numerous construction projects such as several hotels, a casino, roadway improvements, beach revitalization, commercial and residential buildings and entertainment venues. The city also has various main thoughrofares running through and around it such as; State Road 7, I-95, I-595, State Road 84, Federal Highway and Florida's Turnpike. Dania Beach also borders Fort Lauderdale International Airport and Port Everglades. This causes large amounts of vehicular traffic and vacationers to pass through or lodge in the city. During Dania Beach's growth, there has been an increase in conveyance and business burglaries. In 2018 (January thru July) there have been a total of 177 conveyance burglaries reported. In 2018 (January thru July) there have been a total of 42 business burglaries reported. A majority of the cases stem from the numerous parking lots and commercial areas located within the city. Covert surveillance will be conducted by assigned personnel at locations determined by the data provided by the Regional Crime Analyst. All activity (Field interviews, citations and arrests) will be documented by each employee on an end of shift report. Any suspects detained will be interviewed/debriefed by a detective. Assigned personnel will meet with surrounding jurisdictions to discuss crime trends and possible suspects.

As a state accredited agency, the Davie Police Department takes pride in our reputation as a professional, progressive police department. Our mission is serve and protect the rights and property of the citizens of Davie, while safeguarding the quality of life by upholding laws with integrity, professionalism and a partnership with the community. The Davie Police Department develops partnerships with members of the community to ensure policing strategies and resources are utilized to maximize crime prevention techniques. Funding opportunities through available grants further afford the Davie Police Department the opportunity to purchase equipment which support the overall goals and objectives of safeguarding the community.

The Davie Police Department intends to utilize grant funding from the Edward Byrne Memorial Justice Assistance Grant (JAG) to purchase of technological equipment. The purpose of the grant funding request is to provide necessary equipment for the Mobile Command Vehicle and for the Communications Unit. The technology purchase will be conducted in compliance with all applicable procedures and guidelines established by the Department of Justice for the Justice Assistance Grant.

# **Project Narrative:**

# Description of the issues:

The Davie Police Department is requesting grant funds in the amount of 15,912.00 for the purchase of technological equipment. The purpose of the grant funding request is to provide necessary equipment for the Mobile Command Vehicle and for the Communications Unit.

The Mobile Command Vehicle was built to be utilized during staged events, disaster recovery and other events that require a command presence outside of the Police facility. With

budgetary restrictions planned in the upcoming fiscal year's budget, grant funding allows the Davie Police Department the opportunity to purchase equipment that can be utilized in the Mobile Command Vehicle to ensure continuity of police services such as CAD, radio communications and other forms of technology for communications amongst the department personnel. In addition to the technology purchase for the Mobile Command Vehicle, the department will also purchase two radio consoles for the Communications Unit. The radio consoles will replace an antiquated radio that is nearly thirty years old. The new consoles will have the most up-to-date technology, allowing for clear and concise transmittal of information to field personnel. The grants funds will solely be utilized to purchase technological equipment and will be in accordance with specified purchasing guidelines.

### Project Design and Implementation:

Commencing Department of Justice approval, the Davie Police Department will order the equipment for the Command Vehicle. The Dell computer (and associated software/hardware) will enable the full operation of the multiple platforms and software systems needed to run Command Vehicle as a full extension of the Police Department while in the field. Systems needed for mobilizing the Police Department include CAD, radio communications, software such as mobile field reporting and access to internal systems such as shared networks and databases. The total cost for the computer and necessary hardware is \$5,860.00.

In addition to the Dell computer purchase, the Davie Police Department will purchase two radio consoles for the Communications Unit. These consoles will be utilized for radio communications to officers in the field, relaying critical information during the course of their duties. Each radio console is approximately \$5,056.00.

# Capabilities and Competencies:

The Davie Police Department's Program Specialist will work in conjunction with the Information Technology Department and Procurement Division to ensure the items meet the requirements of the grant and are in compliance with the Department of Justice procurement guidelines. Once the equipment has been purchased and delivered, serial numbers (if applicable) will be recorded and agency identifiers will be allocated and recorded for inventory purposes.

#### PROJECT ABSTRACT:

In 1990 the Broward Sheriff's Office entered into a contractual agreement with the City of Deerfield Beach to provide law enforcement services. During the last two years, there has been a sharp increase in the number of reported Aggravated Assaults, Robberies, Auto Thefts, and Larcenies in the City of Deerfield Beach. Analysis depicts that the majority of these incidents can be narrowed down to specific geographical areas of the city. The Deerfield Beach district will use JAG funds to target these specific areas and reduce the aforementioned crimes. Personnel will be used in an overtime status allowing them to concentrate on areas where these incidents are occurring. Daily analytical data will dictate where personnel deployment. The goal of this operation is to reduce both the violent crimes (Aggravated Assault and Robberies) along with the property crimes (Auto Theft and Larenices).

#### **PROJECT NARRATIVE:**

## City Background

The City of Deerfield Beach is located just south of Palm Beach County and consists of just over 15 square miles of land. The city borders to the east the Atlantic Ocean and west of the Florida Turnpike. The estimated population for 2018 is 79,764 and can exceed 100,000 during the winter months with the arrival of part-time residents. The city has easy access to I-95, Florida Turnpike corridors and the Florida East Coast and CSX railways. The City of Deerfield Beach contracted with the Broward Sheriff's Office in 1990 to provide law enforcement services for the entire city.

The City of Deerfield Beach is currently experiencing growth both in residential homes and businesses. Multi-family housing units are currently under construction which will increase the number of permanent residents along with the students attending the local schools. The Broward Sheriff's Office responded to 61,000+ calls for service in 2017 and is on track to exceed 63,000+ calls in 2018.

## **Description of Issue**

The City of Deerfield Beach has seen an increase in violent crimes starting in 2016. In 2016 there were 93 reported Robberies with an increase to 111 in 2017. Aggravated Assaults went from 146 to 17. Property crimes also increased from 2016 to 2017, Auto Thefts went from 220 to 261 and Larcenies went from 1597 to 1771. The Crime Index per 100,000 rose from 3180 in 2016 to 3,349 in 2017. A closer analysis of these crimes shows the following trends:

- In the majority of robberies, the offender either displayed a weapon (firearm/knife) or indicated he had one.
- Offenders are using social media apps to meet with victims who are legitimately selling merchandise only to become a victim of a robbery.
- In a majority of the Aggravated Assaults, the offender had a weapon.
- New trends in auto thefts have been emerging for the past year. Vehicles are being stolen using cloned key-fobs. The crime analysis unit has been tracking where the vehicles are being recovered and more than one-third have yet to be recovered indicating they are either being chopped for parts or shipped to other countries.
- Suspects who are committing larcenies at large retail centers have become better
  organized and are using counter-surveillance tactics to elude the patrol officer.
  Subjects are using cell phones to communicate with each other, using fire exits as
  escape routes, and devices to disable anti-theft locks on expensive items.

The on-going challenge for patrol personnel is finding time to address these issues. Just to complete a simple misdemeanor battery report takes up to ninety minutes (90) to complete. Deputies are now required to take statements, pictures, and submit everything into evidence. More complex reports could take hours with all the new requirements implemented by the State.

# **Capabilities and Competencies**

JAG funds will allow personnel in an overtime status to be free from answering calls for service and concentrate on specific areas where the majority of the aforementioned crimes are occurring. These funds will allow personnel to take time to become creative in setting up their own surveillance, reverse stings, park, and walks, and more community interaction to develop intelligence and to promote the use of CrimeStoppers where residents with information on crimes can remain anonymous.

# Plan for Collecting the Date and Performance Measures:

Deerfield Beach is assigned a crime analyst who has access to real-time data including calls for service and arrests. The crime analyst will be able to geo-code incidents as they occur and assist with the deployment of our personnel into those specific areas. At the end of the week, supervisors will evaluate results from the deployment of personnel. Supervisors will review arrests, calls for service, citizen contacts, and if the location has moved or remained static.

Our performance measures will include:

- Reduction of violent crimes along with the reduction of auto thefts and larcenies.
- Arrests directly related to violent crimes and/or auto thefts and larcenies.
- Reduction in calls for service for violent crimes and/or auto thefts and larcenies in the targeted areas.

### PROJECT ABSTRACT:

The Fort Lauderdale Police Department will utilize the FY 2018 Byrne/JAG funding in order to enhance investigative and public safety capabilities. This will be accomplished via the provision of the following: security upgrades to the Evidence Warehouse, acquisition of traffic safety and public notification equipment to control the follow of motorized and pedestrian traffic during emergencies and large scale events, and forensic laboratory equipment to improve latent examinations and evidence photography.

### **PROGRAM NARRATIVE:**

# This application contains proposals for three distinct projects.

Project #1: Evidence Warehouse Security

**Description of the Issue**: This project seeks to improve the preservation of evidence stored at Fort Lauderdale Police Department's off-site evidence facility. The facility currently has no camera monitoring features installed at this location. This could potentially create issues related to chain of custody, tampering or evidence damage (e.g. thru a fire or a loss of power).

**Design and Implementation**: This off-site evidence warehouse, which is over 10,000 square feet, holds approximately 100,000 pieces of evidence. The evidence stored here includes critical investigations of sexual battery cases and homicides (both solved and unsolved). Funding will be used to acquire a camera monitoring system which will augment the security alarm system currently in place. The International Association for Property and Evidence Inc. recommends camera monitoring systems be utilized in all areas of evidence units to reduce liability to the agency. This will be accomplished by improving the ability to control and identify those who access the evidence areas, thereby ensuring that chain of custody is properly maintained. It will act as a deterrent in preventing the alteration, unauthorized removal, theft or other compromise of evidence stored by the agency.

Secondly, the camera monitoring system will address security concerns in the event of an unauthorized forced entry at the facility. The Evidence Unit is comprised of five Evidence Technicians and an Evidence Custodian. Each day a staff member is required to respond to the facility to visually check on the status of the building, in order to determine if any security breaches have occurred. This is necessary as there are frequent instances of alarm activation which requires the response of not only a law enforcement officer, but also an Evidence Unit staff member, as department personnel are not permitted to access this facility unaccompanied. This creates a negative impact on the efficiency and productivity of the unit as a staff member is away from their primary duties of intake, recording, and transfer of items of evidence for several hours. Furthermore, the camera monitoring system will enhance our ability to view evidence at the off-site location 24 hours a day/seven days a week, in real time, potentially reducing the number of alarm drops to this location. This could negate the need for a law enforcement officer to be dispatched to the facility; thereby permitting our officers to remain in service and available to respond to needs of the community. If however, a crime did occur at the facility, the camera system could potentially provide material evidence.

Capabilities and Competencies: The infrastructure and technology needs of the camera monitoring system will be researched by the City of Fort Lauderdale Information System Department. They will ensure network capabilities, remote accessibility and cloud storage issues are addressed. Due to the estimated cost of this project, Information Systems and the Evidence Unit will work with Fort Lauderdale Procurement to purchase the system. The Evidence Custodian will be responsible for ongoing maintenance and sustainability of the system.

**Performance Measures**: On-going reporting related to the status of the camera monitoring system will be provided on a quarterly basis.

### Project #2 – Traffic Safety & Public Notification Project

**Description of the Issue**: This project seeks to improve the traffic safety environment for Fort Lauderdale's bicyclists, motorists and pedestrians. The city hosts many major large scale events annually which can create crowd control and traffic safety issues. Without an appropriate strategy and implementation of protocols, public safety may be negatively impacted resulting in property damage, injury and/or loss of life. Additionally, equipment is being requested to address deficiencies related to real time notification of the public of a critical situation and guidance and information as to how to respond to said situation.

**Design and Implementation**: Whether a large scale event, like a concert or protest, or an emergency evacuation scenario, appropriate and effective traffic controls are required. The use of traffic cones and cone bars are an easily recognizable, deployable and cost effective means of directing large numbers of people whether on foot or operating a vehicle. Within recent years, this city has seen an increase in outdoor events and protests, which has highlighted the need to increase the inventory of traffic cones and bars. The bars are used to connect two traffic cones by hooking over the top of the cone, creating a 10 foot long barrier. The bars are a cost effective alternative to additional traffic cones, as use of one bar negates the use of three or four traffic cones. It also decreases storage needs compared to traffic cones.

Secondly, funding will be used to acquire a hailing device that can be utilized in a multitude of applications. The LRAD (Long Range Acoustic Device) is a lightweight, water-resistant, portable communication device that improves the capability of public safety personnel to

provide instructions up to 600 meters away. It is powerful enough to permit personnel to deliver clearly heard messages into building and vehicles. This capability to transmit focused, directional broadcasts for targeted communication, while personnel can be stationed at safe standoff distances is invaluable in many applications such as for: Emergency evacuations/alerts (e.g. hurricane threat) and Crowd Control (e.g. dispersal protestors). If an agency were to attempt to respond to the scenarios as previously listed, traditional methods would likely be employed such as the use of robo-calls, a bullhorn, digital messaging signs or deployment of personnel into the field. The LRAD transmits a very clear message, while bull horns are not clear/intelligible even to those within close proximity. The LRAD can reach hundreds of people quickly in lieu of putting people on the ground, so that personnel can be diverted to other emergency tasks. The LRAD can transmit various audio files and specific instructions in multiple languages versus digital messaging signs that display only a limited and abbreviated message. Acquiring this device enhances the efficiency and effectiveness of the department due to its extensive range that can transmit messages to reach persons in high rise buildings and across great distances; and because LRAD can change direction and location, it is capable of delivering targeted message. There are also additional benefits that can be gained by entities that deploy LRAD in instances of civil disobedience such as lower instances of property damage, lower number of arrests, and decreased likelihood of officer harm.

**Capabilities and Competencies**: Acquisition and deployment of the traffic cones, bars and LRAD will be responsibility of the Special Events/Emergency Management Captain. This Special Events/Emergency Management unit is tasked with operational planning and coordination of departmental response to all planned and unplanned large scale events.

**Performance Measures**: On-going reporting related to the use of the traffic control and public notification equipment will be provided on a quarterly basis.

# Project #3 - Forensic Evidence Efficiency Improvements

**Description of the Issue**: This project seeks to reduce inefficiencies in latent photography and print examination.

The Fingerprint unit currently is without a key piece of equipment that can assist when difficult latent prints are being compared. Not having this equipment results in delays in print examination and therefore investigative follow-up.

The Crime Scene Unit is experiencing workflow efficiency as a result of not having enough workstations dedicated to latent photography. Since there is currently only one workstation, CSU personnel must wait until the workstation is available. This results in an interrupted and inefficient workflow.

**Design and Implementation**: The Fort Lauderdale Police Department's Fingerprint Unit is comprised of two latent print examiners. Latent print examiners use their expertise to determine whether the information present in a comparison of two individuals finger/palm prints is sufficient to conclude that the prints were from the same source. This determination is based on the examiner's assessment of the quantity and clarity of corresponding features, their relationships, and their specificity. On average the department's two latent examiners process and compare approximately 3600 prints annually. In instances where latents are typically difficult to compare, a device called the Comparator can be used to enlarge the whole latent and minutiae for easier examination and comparison with the known standard.

Latent print examination can be complex because latents are often small, unclear, distorted, smudged, or contain few features; can overlap with other prints or appear on complex backgrounds; and can contain artifacts from the collection process. A Comparator possesses dual optics (providing 6x magnification), rack-and-pinion focus, a dual-image viewing screen, and a built-in ambient light shield. The viewing screen will enable both examiners to view the characteristics of the latent and the known standard at the same time, which is of great assistance when examining difficult latents. The Comparator is able to project images from a variety of sources including photographs, tape lifts, hinge lifters (transparent or opaque) and rubber lifters. The device contains an internal exhaust fan to keep the projection lamp cool, ensuring maximum lamp life. Obtaining the Comparator (and additional bulbs) will greatly enhance the ability of the latent examiners to compare difficult latents, thereby aiding in investigative follow-up.

The Fort Lauderdale Police Department's Crime Scene Unit (CSU) is comprised of 9 staff members including the unit's sergeant. They collect and process thousands of items retrieved from crime scenes each year. The items are examined for latent, DNA or trace evidence.

During the course of processing for investigative follow-up, the evidence is documented using special forensic photography methods. This task is completed at the single dedicated macrophotography workstand that exists in the CSU laboratory. However, there is often a backlog of evidence to be photographed due to the volume generated by CSU, in addition to the insufficient number of photography workstands available. Acquiring a second workstand will increase workflow efficiency by decreasing any delays in photography incurred due to the unavailability of equipment.

**Capabilities and Competencies:** Acquisition of the Comparator will be the responsibility of *Examiner Blake, who* has been employed by FLPD for 16 years and is a member of the International Association for Identification as well as its Florida Division. He has 16 years' experience as Fingerpint Analyst, which includes but is limited to, latent analysis, verifications and AFIS entries of latent prints. He will be project's primary point of contact.

Acquisition of the workstation will be the responsibility of *Investigator Norcross*. She has a Master of Science degree in Forensic Science from the University of Florida and is an IAI Certified Crime Scene Analyst. She has over 900 hours of training in multiple disciplines within her field of practice, 14 years' experience as a Crime Scene Investigator investigating major crimes, and has given expert testimony in court in the areas of Bloodstain Pattern Analysis and Shooting Reconstruction. She will be the project's primary point of contact.

**Performance Measures**: On-going reporting related to the use of these forensic devices will be provided on a quarterly basis.

The City of Hollywood's "Vision Statement" includes the *Preserve Life & Property* initiative by increasing technology driven public safety efforts. As such, the Hollywood Police Department has utilized prior year BYRNE - JAG grant funding to increase the Department's technological capabilities in this field which has led to substantial reductions to a variety of Uniform Crime Reporting Part 1 crimes. In continuing with this focus, the Hollywood Police Department is requesting the use of its 2018 BYRNE - Justice Assistance Grant funds distributed via the City of Pompano Beach to purchase law enforcement technology in the amount of \$43,041.60. The Department will utilize this grant funding to purchase a fixed mount dual camera system license plate reader to be deployed in the field. While this funding globally enhances a number of the Department's technology driven efforts, it will substantially aid the Domestic Violence, Violent Offender and Auto Theft Programs by providing real time data to officers and detectives in the field. Additionally, the grant funded technology may be utilized by crime analysts to input suspect or crime information developed through data analytics to create geo-fencing opportunities within identified geographical locations.

### **PROGRAM NARRTIVE:** include the following information:

The City of Hollywood Police Department utilizes intelligence led and problem solving initiatives as a bedrock of its community oriented policing strategies. The Department's Crime Analysts utilize geospatial and temporal data analytics to effectively allow the Department to practice predictive policing while addressing the majority of Uniform Crime Reporting Part 1 crimes. During previous JAG grant cycles, the Department utilized this funding source to establish technology platforms which allow officers/detectives to remotely access information and reporting systems from the field thereby increasing their effectiveness and efficiency while conducting criminal investigations, criminal intelligence gathering and case management. The Department utilizes data-driven proactive policing strategies which emphasize offender intervention along with crime and disorder hot spot intervention to effectively deploy its resources to address crime trends and community concerns. As a result, the City of Hollywood realized an overall reduction of 8% in Part 1 crime for 2017. However, despite this success, the Department continues to see periodic increases in motor vehicle thefts. Additionally, in analyzing crime trends, the Department established a correlation between domestic violence offenders and other violent crime which led to the implementation of the Department's Offender Based Domestic Violence Reduction Initiative during 2015. In 2017, the program was expanded to adapt the offender based approach to all violent offenders identified with the City of Hollywood.

In continuing with this focus on technology, the Hollywood Police Department is requesting the use of its 2018 BYRNE - Justice Assistance Grant funds distributed via the City of Pompano Beach to purchase law enforcement technology in the amount of \$43,041.60. The Department will utilize this grant funding to purchase a fixed mount dual camera system license plate reader to be deployed in the field. The Department will deploy the fixed mount LPR camera system to capture all vehicular traffic entering the City of Hollywood via one of its major roadways by

affixing the system to a pole located in close proximity to the roadway. The LPR system will then provide real time criminal information data to officers/detectives in the area through mobile technology platforms. In addition, criminal investigative information regarding suspect, wanted or felonious vehicles may be uploaded to the LPR system to detect and notify officers/detectives of the vehicle's presence in the area. In addition, this technology has also been used to conduct traffic safety operations targeting drivers with suspended licenses and uninsured motorists. The fixed mount LPR system will he used in conjunction with other mobile technology purchased through previous BRYNE JAG grant cycles. The Department's CCTV Unit is tasked with monitoring mobile technology platforms such as the license plate reader and closed circuit television programs, and will therefore oversee the implementation of this grant purchase. The CCTV Unit will also capture analytical data once the system is installed.

#### PROJECT ABSTRACT:

The City of Lauderdale Lakes was incorporated in 1961 and has grown to a population in excess of 35,000 residents. The city encompasses approximately four square miles and is located "In the Heart" of Broward County. The Broward Sheriff's Office entered into its first police service contract with a municipality in 1978 when it entered into an agreement with the City of Lauderdale Lakes to provide comprehensive police services to the City and renegotiated their current police service contract in 2011.

The City of Lauderdale Lakes is being allocated \$17,477 from the FY 2018 Edward Byrne Memorial Justice Assistance Grant (JAG) Program towards costs associated with crime reduction and community safety operations.

#### **DESCRIPTION OF ISSUE:**

Historically, the City of Lauderdale Lakes experiences large numbers of property crimes. Although the 2017 Uniform Crime Report (UCR) total Reportable Crimes for the City of Lauderdale Lakes revealed a nominal 15% decrease (2017 = 1652 and 2016 = 1951), the three year average of total reportable crimes = 1800.

Additionally, the categories of robberies and burglaries remain at consistently high levels; with a three year average of 96 robberies (2017 = 93, 2016 = 102, and 2015 = 94), and a three year average of 248 burglaries (2017 = 238, 2016 = 266, and 2015 = 239).

#### PROJECT DESIGN AND IMPLEMENTATION:

Crime reduction operations have been shown to have a significant impact on total reported crimes and emphasize community safety. Crime reduction operations are more easily staffed with personnel working in an overtime capacity as these deputies are free from normal calls for service. Based on comprehensive crime analysis, crime reduction operations will be directed to areas determined to be experiencing increases in burglaries and robberies within the City. Crime reduction operations can take the form of surveillance operations, decoy operations or area saturations that emphasize a zero tolerance policy. Current staffing levels and minimum staffing requirements do not allow for on-duty deputies to be detached to crime reduction operations.

Since the deputies will be hired as a dedicated resource, they will be free from normal calls for service and will remain strictly assigned to the specified operations area.

Therefore, the City of Lauderdale Lakes will budget \$17,477 of the FY 2018 JAG Grant funds, toward costs associated with crime reduction and community safety operations, as follows: ninety-seven (97) hours based on an average overtime rate of \$68.00 per hour.

The goal of the crime reduction operations will be to reduce the occurrences of these crimes and to emphasize community safety within the City of Lauderdale Lakes. Reductions in these crime categories will help reduce the overall crime rate within the City and a continuous community involvement will strengthen established partnerships.

One of the main concerns while dealing with an active shooter is being able to quickly diffuse the situation while minimizing the risks to responding police officers, and ensuring a minimal loss of lives. The Lauderhill Police Department is proposing to use the 2018 JAG grant funds to purchase Ballistic Active Shooter Kits for Police Officers.

The recent spate of combative and life threatening situations all across the country, with active shooters using high powered weapons and endangering lives, require a proactive approach at multiple levels to enable and empower police departments and officers. The Lauderhill Police department's proposal to utilize the 2018 JAG grant to purchase ballistic gear is will enable the agency to outfit police officers and bolster their safety and security with an added layer of protection at threat level III. In the eventuality of a lethal situation, this proposal will equip our police officers with a "Active Shooter Kit" comprising ballistic helmets and ceramic rifle plates with a harness carrier -- the highest threat level protective gear currently available. This project is based on Lauderhill Police department's view of enhancing the safety and security of its police officers as they go on their line of duty, and empowering their well-being and peace of mind with the knowledge that they are equipped with the latest and highest threat level protective gear available.

#### PROGRAM NARRATIVE:

### Description of the issue

All across the country there has been a marked increase in the number of active shooter situations using a high powered weapon claiming innocent lives. The places targeted include work organizations, schools, and shopping malls, to name a few. This

has prompted government action and measures at different levels, including creation of strategic groups and think tanks to a more basic community level action plans.

The Lauderhill Police department has initiated several measures to ensure its preparedness in the eventuality of an active shooter situation, especially, in the wake of the February 14, 2018 school shooting in the City of Parkland in Florida, that is in close proximity, about 20 miles from Lauderhill. That incident claimed 17 innocent lives. Of utmost priority then, is the goal of the Lauderhill police department to further secure and protect public places in Lauderhill that attract large crowds of people, and pose elevated risk in threat situations. To achieve that, it is of equal priority to be fully prepared and equipped with the necessary gear and protective wear. The 2018 JAG grant funds will be used to address purchase of enhanced protective gear for wear by police officers exposed to an active shooter scenario, to protect them from high powered automatic weapons that are often being used in such situations.

Lauderhill has a large number of retail facilities, including the Swap shop, several shopping malls, The Lauderhill Performing Arts Center, and the Broward Regional park that hosts international sports teams and matches. More importantly, there are ten public schools in Lauderhill, attended by young children and youth. Currently steps are being taken to recruit more school resource officers to each school and in and around their vicinity. However, the Lauderhill police department wants to ensure that the police officers are fully equipped with the highest threat level protective gear and equipment available to perform their duty effectively and efficiently in the threat of a dangerous combative situation.

Nothing is more important to a law enforcement officer than to be able to approach a combative situation and secure and protect lives. Equipping police officers with highest

threat level enhanced protective gear and equipment provides them the ability to enter a lethal situation and move ahead for a successful outcome. Moreover, wearing the enhanced added protective gear gives the police officers the peace of mind and confidence knowing that they are equipped with the latest and the highest threat level protection available in the market. The police department has a responsibility toward the police officers before deploying them in a lethal situation, and thus the Lauderhill Police department is seeking to use the 2018 JAG grant funds to purchase the enhanced, protective threat level III ballistic "Active Shooter Kits".

#### | Project Design and Implementation

The proposed "Ballistic Active Shooter Kit for Police Officers" project using the 2018 JAG grant funds seeks to purchase enhanced protective gear for wear by police officers exposed to an active shooter scenario. This project is designed to protect the lives of our police officers, from the high powered automatic weapons that are often found to be used in active shooter situations.

This project will enable the police department to fully outfit and equip all the frontline/ first responding officers with the needed ballistic protection by providing them with the Active Shooter Kit. The kit is intended to be worn over an entire uniform and mainly comprises a plate carrier, rifle plates and a ballistic helmet. They are fast donning pieces of equipment that provide the police officers a great deal of added protection while actively engaging an active shooter in a lethal situation.

The rifle plates come with a 10-year warranty are a stand-alone multi-hit rated plate (they can withstand multiple rounds). Their ballistic rating is a Level III Rifle Plate that is capable of withstanding the rounds below:

7.62 x 51mm M80 traveling @ 2780 feet/second

.223 60gr

M43 SS109

M42 PD Ball MSC

M855 SS109

The M855 typically poses the greatest threat, as it has a steel core and is a hard round to defeat. the 7.62 and the .223 are threats that are commonly used. Attached photographs are from a ballistic shoot that shows the capabilities and protection offered by these rifle plates. The plate carriers will have shoulder pads, and harnesses and fasteners that have adjustable features.

The ballistic helmets have a 7-year warranty and will help cut down on replacement costs compared to the previous versions with a 5-year warranty. Additionally, this helmet has a ratchet dial suspension system with a 4-point integrated harness with unique buckle system with no loose straps). The Dial Ratchet Mechanism adjusts the fit band with a simple one-handed operation. Moreover, it is adjustable while on the move. It is height adjustable nape pad and the impact material does not contact the head in normal operation. The helmets will be fitted to conform to the wearer to provide the best possible fit and coverage.

The active shooter kits and helmets will be purchased from an approved authorized dealer providing equipment that complies with the National Institute of Justice (NIJ) ballistic standards. To ensure the best possible use of the 2018 JAG grant funds, we have worked

with the dealer to provide discounted prices on the "WSCA-NASPO" cooperative purchasing program contract pricing for participating state governments. This discount will enable the department to purchase more equipment and make the best use of funds.

The quartermaster will receive the Active Shooter Kit and equipment and maintain the numbered inventory log along with photographs of the equipment. He will assign the Active Shooter Kit to individual frontline police officers and first responders, and maintain records and acknowledgement signatures. The Active Shooter Kit will become a part of the officers' patrol equipment to be carried in their assigned police vehicle. This will provide them easy access to don this over their regular uniform. It will enable them to make the quickest and most efficient response to make an immediate entry and neutralize the killer in an active shooter situation, with the ultimate goal of preserving life.

#### **Capabilities and Competencies**

The Lauderhill Police Department provides services to over 70,000 residents in the City supported by the efforts of 124 sworn officers. The department has a strong chain of command and includes a full-time internal affairs unit, supported by well documented policies and procedures.

The 2018 JAG Grant will be coordinated by Girija "GG" Gothoskar. She will be the point of contact, and her duties will include preparing and submitting the grant application including the budget, and preparing any modifications as required. She is well-qualified with a Master's degree and has successfully managed several grant programs. She will coordinate with the Asset and maintenance coordinator for purchase of approved items, and their inventory. She will work with the Quartermaster to ensure assigning equipment to police officers and maintain accurate logs. She will also coordinate with the Finance department to ensure maintaining

invoices and accounts. She will coordinate the required financial reports that will be prepared by the City Finance Department for submission. She will be responsible to prepare the required JAG quarterly progress reports and maintain all documents and back up. She will ensure that she is available to answer any questions posed by the grant audit staff.

This project will be overseen by Deputy Chief Allen Siegel and Lieutenant David Hennessy. Lieutenant David Hennessy will be the supervisor and the first line of review for all information submitted. He will monitor the grant progress and will assign staff as necessary to ensure the success of the program. He will also be responsible to ensure that the Department is meeting established goals, and all personnel are completing assignments as required. He will be responsible for ensuring that the Department is meeting all timeframes.

The quartermaster Allan Lerner will be charged with the responsibility of managing the care and assignment of the new equipment and ensuring that all employees have been properly trained in how to use and or wear the equipment. He will maintain adequate information of who has been assigned the equipment and when.

#### **IV** Plan for Collecting Data for Performance Measures

The quartermaster Allan Lerner will be charged with the responsibility of taking delivery of shipments, verifying contents, proper storage and managing the assignment of equipment in the Active Shooter Kit to police officers. Performance measures will include a timeline starting from fiscal year October 1, 2019 once grant funds are released for reimbursement. It will include time for the dealer to have individuals measured for some of the equipment as required, acquiring a purchase order from the Finance department of the City of Lauderhill and releasing the order for the approved amount of Active Shooter Kits.

Data will be collected at several check points to ensure accuracy, beginning at the time the shipment is received and packages are opened. Inventory records will be created and maintained along with assignment records and photographs verified by the signature of the officer receiving the equipment along with a description and total number of items of the equipment. The quartermaster will also assist with providing instruction on proper use and wear of equipment. Further, it will be followed up with in service and roll call training on proper donning of the equipment. Routine uniform inspections by supervisors will include this equipment.

Performance measure data will be documented both quantitatively and qualitatively with a subjective description. Active Shooter Kit assignments will be compared to the main roster of the police department. Case history will be documented with number of incidents detailed with a date, location and description of SWAT or active shooter and barricade situations. In the eventuality of an actual shootout and exchange of fire, the number of rounds fired and withstood by the rifle plates and helmets of the Active Shooter Kits, and the type and description of the lethal weapons used will be documented. All data will be routinely maintained case by case, per occurrence and compiled for reporting to DOJ on a quarterly basis.

By constantly scanning traffic or recording license plates during incidents on the road, officers are assisting one another and making their jobs easier. If a vehicle is involved in a traffic violation for instance, that license plate will be registered in the database as an offender. Then, the next time that vehicle is involved in an incident, an officer will know about the prior incident well in advance of engaging the driver. A larger database of license plates will mean a safer road for officers and average citizens alike. The software can even scan multiple plates concurrently as an officer navigates through busy streets. 

#### **PROJECT ABSTRACT:**

At its creation in 1963, the city of North Lauderdale was largely farmland on the western edge of Broward County. Orginally, the grazing pastures was for cows, horses and an agricultural area for stringbeans until a famed architect Morris Lapidus turned his attention to planning a city that would be North Lauderdale. His vision has shaped North Lauderdale structures into whimsical "beacons" lending the city prominence and distinction for affordable homes to accommodate young family-oriented people. Unfortunately, historically the population records date back to 1970 with census being 1,213. The city has a total area of 4.65 square miles and 0.04 square miles of water. On July 13, 2013, North Lauderdale celebrated it's 50th Anniversary. As of 2016, the population was estimated at 43,699.

Many things have changed and a lot has stayed the same. In October 2001, the city of North Lauderdale entered into a contractual agreement with the Broward Sheriff's Office to provide law enforcement services. Its operating budget allows for a Captain, two (2) Lieutenants, seven (7) Sergeants, seventy-seven (48) road patrol Deputies.

North Lauderdale has very diverse communities and has over the years welcomed an influx of Colombian, Jamacian, Haitian and Trinidadian/Tobagonian families. Of the city's current population, 13.7% are living below the poverty level. 19.3% has a female householder without a husband present and there is a high number of children under 18.

While the city enjoys marginal crime it has concerns with an increase in auto thefts and criminal activity of youth. The Department of Juvenile Justice reports that there are 26 youth Probation in the city of North Lauderdale. To address concerns the Edward Byrne Memorial Justice Assistance grant will be utilized for preventing juvenile involvement in truancy and curtail the increase in property crimes.

#### PROGRAM NARRTIVE:

#### Description of the issues:

The proposed expenditures of this grant would be for the purpose of crime prevention, crime reduction initiatives, youth and community education and enforcement in the City of North Lauderdale. The grant would be utilized by the Broward Sheriff's Office (BSO) North Lauderdale District in accordance with the City's contract with BSO. Specifically, BSO, North Lauderdale District intends to use this grant to fund crime prevention and youth safety education and operations through overtime and purchase of crime prevention and youth and community safety education materials etc). Like many municipalities North (pamphlets. coloring books, Lauderdale requires assistance to combat criminal activity within its borders and preventing the various crime trends from impacting residents and visitors quality of life. The primary focus will be on public safety and crime prevention education, as well as efforts to increase interaction with the community's youth to reduce youth delinquency.

#### Project Design and Implementation:

This is accomplished with the Byrne-Jag funding utilized to: increase patrol and youth and community interaction with law enforcement at parks, homeowner's meetings and other community events; implement crime prevention strategies; deter our youth from criminal activity, educate the public on crime trends and drug awareness/education and distribute safety and crime prevention educational materials at parks, homeowner's meeting, schools and other community events and gatherings. Additionally, resources will be dedicated to creating positive circumstances where youth may interact with law enforcement in a non-confrontational and collegial manner.

#### Capabilities and Competencies:

Law enforcement partnerships with Broward County School Board, Juvenile Justice, Juvenile SOA, Juvenile Probation, Juvenile Judges, BSO Juvenile Services, Homeowner associations, as well as the City's Parks and Leisure Department are all fundamentals to ensuring success of meeting the programs goals.
