AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE CONTINUING CONTRACTS BETWEEN THE CITY OF POMPANO BEACH AND DESIGN KOLLABORATIVE ARCHITECTS PLANNERS, INC., WALTER ZACKRIA ASSOCIATES, PLLC, CURRIE SOWARDS AGUILA ARCHITECTS, INC., DESIGN2FORM, LLC, AND THE TAMARA PEACOCK COMPANY ARCHITECTS OF FLORIDA, INC., FOR PROFESSIONAL ARCHITECTURAL SERVICES (RLI 26-002); PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to law, ten (10) days' notice has been given by publication in a newspaper of general circulation in the City, notifying the public of this proposed ordinance and of a public hearing in the City Commission Chambers of the City of Pompano Beach; and

WHEREAS, a public hearing before the City Commission was held pursuant to the published notice described above, at which hearing the parties in interest and all other citizens so desiring had an opportunity to be and were, in fact, heard; now, therefore,

BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the Continuing Contracts for Professional Architectural Services between the City of Pompano Beach and Design Kollaborative Architects Planners, Inc., Walter Zackria Associates, PLLC, Currie Sowards Aguila Architects, Inc., Design2form, LLC, and The Tamara Peacock Company Architects of Florida, Inc., copies of which Agreements are attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

SECTION 2. That the proper City officials are hereby authorized to execute said Agreements between the City of Pompano Beach and Design Kollaborative Architects Planners,

Inc., Walter Zackria Associates, PLLC, Currie Sowards Aguila Architects, Inc., Design2form, LLC, and The Tamara Peacock Company Architects of Florida, Inc.

SECTION 3. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

SECTION 4. This Ordinance shall become effective upon passage.
