**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, RESCINDING RESOLUTION NO. 2019-50, AND TO APPROPRIATE ANNUAL FUNDS IN AN AMOUNT NOT TO EXCEED TEN THOUSAND DOLLARS (\$10,000.00) PER EACH COMMISSIONER AND THE MAYOR TO UTILIZE SOLELY FOR THEIR SPECIFICALLY REQUESTED CITY EVENTS AND PROGRAMS AND REPORTED TO THE CITY COMMISSION; PROVIDING AN EFFECTIVE DATE.**

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH FLORIDA:**

**SECTION 1.** That Resolution No. 2019-50, passed and adopted December 11, 2018, be and the same is hereby rescinded.

**SECTION 2.** That the city shall budget annually an amount not to exceed Ten Thousand Dollars (\$10,000.00) per each Commissioner and the Mayor, to utilize solely for support or funding of their specifically requested city events and programs or to support other local matters that benefit residents in their district or in the city and expenses associated therewith.

**SECTION 3.** That the Mayor and City Commissioners shall direct all specific requests to hold events, programs and also for the use of city facilities if required for same, to the City Manager and not to city staff in accordance with Section 13 of the City's Charter.

**SECTION 4.** That each desired event or program shall be reported to the City Commission by the City Manager during his Report section of the next available City Commission meeting. Any such event, program and any use of city facilities must serve a public purpose by providing a benefit to city residents and such activities shall be open to city residents. After consideration of the City Manager's report, should a motion be made and seconded by a City Commissioner, and a majority of the City

Commission determines that no public purpose is served by contribution to the event or program, then no funds shall be provided for the event or program.

**SECTION 5.** That, if required for an event, application for Public Event permit per Section 98.07 of the City's Code shall be submitted for review by the Public Event Committee to ensure adequate facilities, staff and police and fire services are utilized for the events, and that the costs of police details and other special services are paid from the designated funds for such events. Thus the initial request per Section 2 above should be made as close as practicable to the pre-event date submission requirement of 45 days set forth in section 98.07, to ensure adequate time to prepare for the event, if required by its location, anticipated attendance and its nature.

**SECTION 6.** That to avoid the appearance of holding an event for the election or re-election of an incumbent Mayor or City Commissioner with public funds, no requested events or programs shall be held within six (6) months prior to any scheduled election involving the Mayor or any City Commissioner seeking election or re-election to any city or other elected office.

**SECTION 7.** That this shall constitute the exclusive process for any requests for events or programs from the Mayor and Commissioners. Each designated city official may only utilize the aforementioned dedicated funds allocated specifically to them, and funds which are unused at the end of the fiscal year shall revert back to the City's General Fund.

**SECTION 8.** This Resolution shall become effective upon passage.
