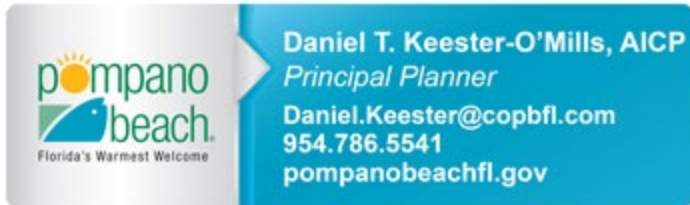

Also please understand that most vendors in the festival will not attend the meeting to voice their opinion because of repercussions that might happen after.

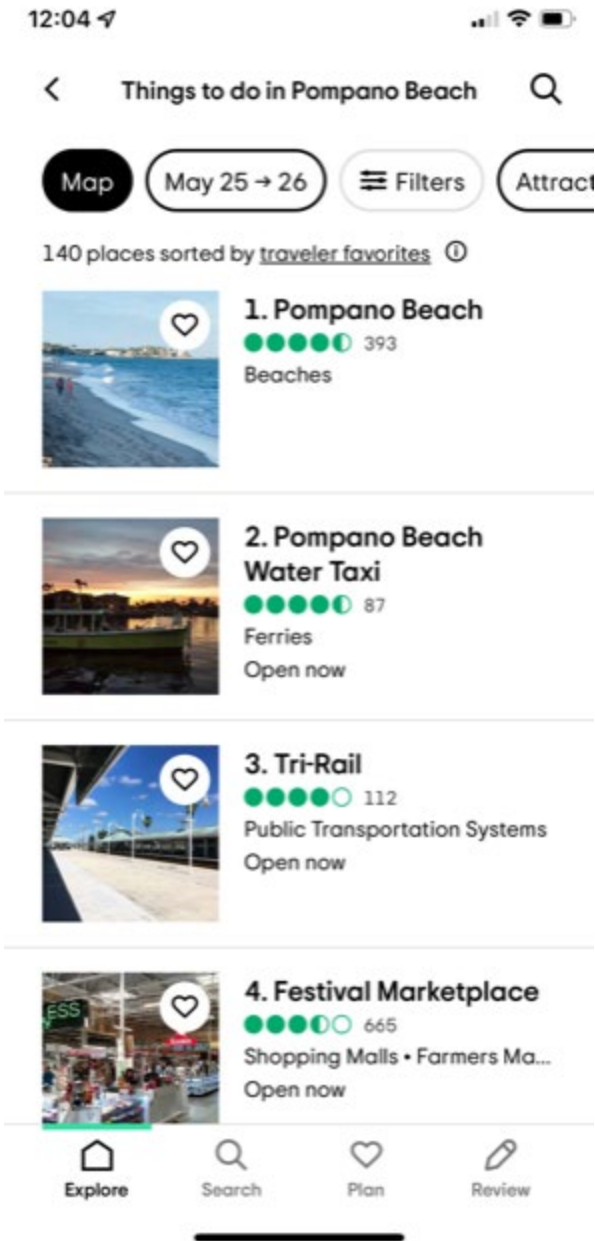
There are many more reasons for not closing the festival but please take the above consideration and I hope you guys will make the right decision because that decision will affect many people's lives in small businesses and customers.
