Subject: FW: Broward MPO - Board Member Vacancy

MPO Rules:

The Broward Metropolitan Planning Organization (BMPO) for Broward County, Florida is a federally mandated independent planning body responsible for transportation planning in the Broward County urbanized area. Established in 1977 by the Florida Legislature, the BMPO was created to direct urban transportation planning and the expenditure of federal and state funds. It is the lead agency responsible for developing and administering plans and programs to maintain eligibility and receive federal funds for the transportation planning and funding allocation in Broward County, Florida. The BMPO works collaboratively with the public, planning organizations, government agencies, elected officials and community groups to develop transportation plans.

The twenty-five (25) members of the BMPO include representatives from the municipalities within the County, the South Florida Regional Transportation Authority (SFRTA)/Tri-Rail, the Broward County School Board, and the Broward County Board of County Commissioners. There are thirteen (13) alternate members who are eligible to vote when a member(s) is absent. The BMPO is divided into five separate districts. The regular and alternate voting membership in each district varies. Each of these members are now parties to the Interlocal Agreement for the Creation of the Broward Metropolitan Planning Organization (Interlocal Agreement) which was effective on August 3, 1977 and amended thereafter, in part, to provide for the current membership of the Organization.

Good Afternoon Mr. Harrison:

It has come to my attention that there is a vacancy on the MPO Board to replace Commissioner Burrie as the City of Pompano Beach's designated representative. We request that the City of Pompano Beach appoint a city commission member to represent the City's interests on the MPO Board.

The MPO Board meets on the second Thursday of every month in the MPO Board Room, located in the Trade Centre South Building at 100 West Cypress Creek Road, Suite 650, Fort Lauderdale, FL 33309 at 9:30 a.m. These meetings are open to the public and participation is encouraged. Enclosed is a copy of the MPO Bylaws summarizing the duties and responsibilities of Board members. A copy of the MPO Boards meeting dates is also enclosed.
