Mark-

We are pleased to inform you of further details regarding the three additional National Opioid related settlements reached by the State of Florida last week. The proposed settlements involve CVS Health Corp, Teva and Allergan Pharmaceutical Companies. We have attached for your review the three Settlement Agreements and three Participation Agreements so that you can begin to take the necessary steps to act on these deals, including the scheduling of a shade and/or board meeting in the month of April.

The proposed settlements are comprised of cash and product to combat the opioid crisis in Florida. With respect to the cash portion, the total is approximately \$813,026,499 (\$484 million from CVS to be paid over 18 years and \$329,026,499 from Teva/Allergan to be paid over 11 years). The proposed settlements also include approximately \$84 million worth of product to combat the opioid crisis (Narcan). Reminder that these proposed settlements would also be governed by the Florida MOU that the county, and almost 100% of litigating subdivisions, entered and executed with respect to the Big Three Distributor and J&J settlements.

As you will recall, the State of Florida was allocated approximately \$1.6 billion dollars from the historic Big Three Distributor and J&J settlements. Thus, these proposed settlements increases Florida local governments' potential recovery to combat the opioid crisis by just over 50%.

Based on the AG's projected estimates and complete statewide participation by litigating entities, your allocation is as follows (over 18 years):

CVS- \$221,000

TEVA- \$89,000

Allergan- \$61,000

As more information becomes available and these projected amounts are fully verified, we will keep you informed.

We recommend participation in all three proposed settlements, and ask, if necessary, that you put the review of these settlements on your next meeting agenda, or as soon as possible in the month of April. Once executed, the Participation Agreements should be e-mailed to participation@nationalopioidsettlement.com with a copy to me. In the subject line, please include "Pompano Beach , Florida" and Participation Forms - CVS, Allergan, and Teva."
