

## ***FIRST AMENDMENT***

**THIS IS A FIRST AMENDMENT to the Agreement for Commissioned Artwork**  
dated \_\_\_\_\_ between:

**CITY OF POMPANO BEACH**, a municipal corporation of the  
State of Florida, whose address is 100 West Atlantic Boulevard,  
Pompano Beach, Florida 33060, hereinafter referred to as "CITY",

and

**INNOVATIVE SCULPTURE DESIGN, LLC**, whose  
mailingaddress is 122 Orleans Drive, Maumelle, AR, USA 72113  
(hereinafter "ARTIST").

**WHEREAS**, the parties entered into an Agreement for Commissioned Artwork to  
fabricate and install a sculpture entitled "Vivacious" on the east side of Powerline Road by the  
south entrance to Harrah's Pompano Beach Casiono on Janury 21, 2025, ("Original  
Agreement"), and approved by City Resolution No. 2025-40; and

**WHEREAS**, the CITY and ARTIST have mutually agreed to extend the Original  
Agreement for one (1) additional one-year period.

### **WITNESSETH:**

**IN CONSIDERATION** of the mutual terms, conditions, promises, covenants and  
payments herein set forth CITY and ARTIST agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein  
incorporated by this reference.

2. The Original Agreement for Commissioned Artwork effective January 21, 2025, approved and adopted by Resolution No. 2025-40, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect for the new contract extension term except as specifically amended herein below.

3. The parties hereto agree to extend the Original Agreement for one (1) additional one-year period, ending January 21, 2027, under the same terms and conditions.

4. This Agreement shall bind the parties and their respective executors, administrators, successors and assigns and shall be fully effective as though the extension had been originally included in the Agreement.
