

REINSTATEMENT AND EXTENSION
TO THE MEMORANDUM OF UNDERSTANDING
BY AND BETWEEN
THE BROWARD SHERIFF'S OFFICE
AND
THE CITY OF POMPANO BEACH

THIS REINSTATEMENT AND EXTENSION is made and entered this ____ day of _____, 2018, by and between the BROWARD SHERIFF'S OFFICE (hereinafter referred to as "BSO") and the CITY OF POMPANO BEACH (hereinafter referred to as "CITY").

W I T N E S S E T H:

WHEREAS, on or about the 27th day of July 2010, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, a Memorandum of Understanding between BSO and the CITY allowing for the administration of the U.S. Department of Justice, Community Oriented Policing Services Hiring Grant, and which allowed for the continuation of nine School Resource Deputy positions was approved on April 28, 2015, ("Original Agreement") by Ordinance No. 2015-47; and

WHEREAS, the term of the Original Agreement was for a three year term expiring on February 28, 2018, and included an additional one year renewal period; and

WHEREAS, the term of the Original Agreement has lapsed without renewal of the Original Agreement; and

WHEREAS, the parties desire to reinstate and to extend the term of the Original Agreement through August 31, 2019.

NOW THEREFORE, in consideration of the mutual terms and conditions contained herein, BSO and CITY agree as follows:

1. The foregoing recitations are true and correct and are incorporated herein by reference.

2. The original Agreement between CITY and BSO, approved April 28, 2015, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect except as specifically amended hereinbelow.

3. The parties hereto agree to reinstate and extend the Original Agreement for a period ending on August 31, 2019.

4. Except as modified herein, all remaining terms and conditions of the Original Agreement shall remain in full force and effect.
