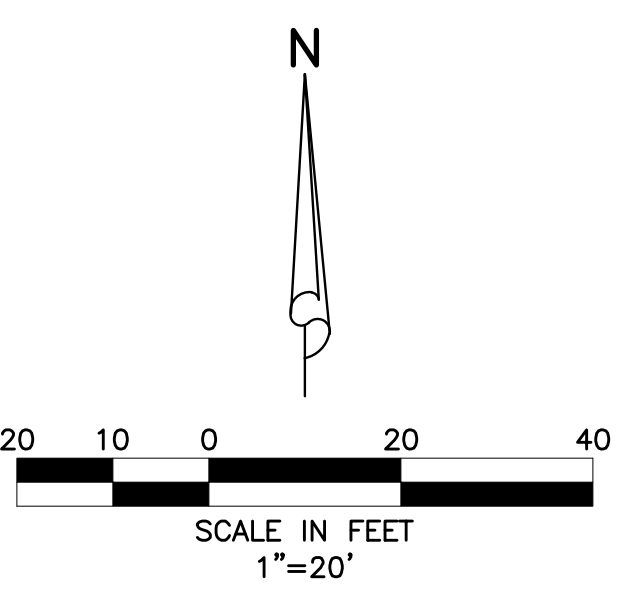


LOCATION MAP

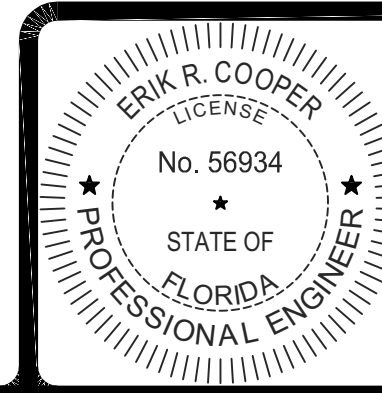
