AGREEMENT

This Seventh Amendment is entered into this ___ day of _____, 2020 by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Pompano Beach, FL (hereinafter referred to as the "CITY").

WHEREAS, on or about November 30, 2015, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, on or about November 2, 2016, BSO and the CITY entered into a First Amendment to reclassify positions; and

WHEREAS, BSO and the CITY entered into a Second Amendment to address modifications to the pistol range; and

WHEREAS, BSO and the CITY entered into a Third Amendment to clarify responsibilities for the P25 Radios; and

WHEREAS, BSO and the CITY entered into a Fourth Amendment to add seven deputy positions and five CSA positions; and

WHEREAS, BSO and the CITY entered into a Fifth Amendment to reclassify a deputy position to a sergeant and an Investigative Aide position to a Crime Analyst position; and

WHEREAS, BSO and the CITY entered into a Sixth Amendment to add a new sergeant and two deputy positions and reclassify the records technician positions; and

WHEREAS, CITY and BSO are now desirous of adding two deputy positions; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. The foregoing recitations are true and correct and are incorporated by reference.
2. The staffing structure as set forth in Exhibit A of the Agreement will be modified by adding two deputy sheriffs. The Exhibit A to this Seventh Amendment is attached hereto and incorporated by reference.

3. Except as modified herein, all remaining items and conditions of the Agreement, shall remain in full force and effect.

RENEWAL OPTION:	Renewable for one (1), five (5) year term upon the City and BSO agreeing to such renewal and the terms and conditions thereto.
