

# EXTENSION AGREEMENT

"CONTRACTOR,"

## WITNESSETH:

**WHEREAS**, the CITY entered into an agreement for beach cleaning and debris removal  
services pursuant to Ordinance No. 2007-56; and

**WHEREAS**, the Agreement provided for two (2) three-year renewal periods; and

**WHEREAS**, the parties have previously exercised this option by Ordinance Nos. 2009-  
08, 2010-48 and 2013-79, and Resolution No. 2016-284 and which will expire on December 29,  
2016;

**WHEREAS**, City now desires to extend the term for an additional 60 day period to allow  
staff time to finalize negotiations of new Agreement with proposer pursuant to RFP E-49-16;

**NOW, THEREFORE**, the parties agree as follows:

1. The term of this Extension Agreement is for 60 days commencing on December  
30, 2016, and ending on February 27, 2017.
2. That all of the terms and conditions in the Agreement approved by Ordinance No.  
2007-56 and subsequently amended by Ordinance Nos. 2009-08, 2010-48 and 2013-79, and  
Resolution No. 2016-284, copies of which Agreements are attached hereto and incorporated

herein by reference as if set forth in full, with exception of Paragraph No. 1 as amended above, shall be incorporated as the terms and conditions of this Agreement and shall, in all other respects, remain in full force and effect.
