SHORT TITLE Approval to award Bid L-24-16, Cured-In-Place Pipe Rehabilitation, Annual Contract
to the responsive, responsible bidder Insituform Technologies LLC, at an estimated cost of
\$3,715,647.80 over the (3) three year term of the contract.

Summary of Purpose and Why:

Bid L-24-16 was issued for the Utilities Department to establish an annual contract for cured-in-place rehabilitation of sanitary sewer and storm drainage pipes as needed throughout the City of Pompano Beach. Bid award is recommended to the responsive, responsible bidder, Insituform Technologies LLC, in the amount of \$3,715,647.80. This solicitation was assigned a voluntary 15% Local Business participation goal and a 15% Small Business Enterprise (SBE) participation goal; the recommended bidder has indicated 1% SBE participation and no Local Business participation. City Commission approval of this bid award is requested.
