AN ORDINANCE OF THE CITY COMMISSION OF THE CITY FLORIDA, **OF POMPANO** BEACH, **APPROVING** AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE CONTRACTS FOR CONSULTING/PROFESSIONAL SERVICES BETWEEN THE CITY OF POMPANO BEACH AND BAXTER & WOODMAN, INC., CALVIN, GIORDANO & ASSOCIATES, INC., CRAVEN **THOMPSON** ASSOCIATES, INC.. & TECHNOLOGIES, INC., LAKDAS/YAHALEM ENGINEERING, INC. AND R.J. BEHAR & COMPANY, INC., FOR CONTINUING **CONSTRUCTION CONTRACT FOR ENGINEERING** INSPECTION SERVICES FOR VARIOUS CITY PROJECTS; **PROVIDING FOR SEVERABILITY**; **PROVIDING** EFFECTIVE DATE.

## BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That six (6) Contracts for Consulting/Professional Services between the City of Pompano Beach and Baxter & Woodman, Inc., Calvin, Giordano & Associates, Inc., Craven Thompson & Associates, Inc., KCI Technologies, Inc., Lakdas/Yahalem Engineering, Inc. and R.J. Behar & Company, Inc., for Continuing Contract for Construction Engineering Inspection Services, copies of which Agreements are attached hereto and incorporated herein by reference as if set forth in full, are hereby approved.

**SECTION 2.** That the proper City officials are hereby authorized to execute said Contracts.

SECTION 3. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

**SECTION 4.** This Ordinance shall become effective upon passage.
