Broward County, Florida**

**AN ORDINANCE OF THE CITY COMMISSION, OF THE CITY OF POMPANO BEACH, FLORIDA, AMENDING CHAPTER 53, "STORMWATER MANAGEMENT", BY AMENDING SECTION 53.12, "STORMWATER FEES," TO MODIFY MONTHLY FEES FOR STORMWATER SERVICES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to Section 180.136, Florida Statutes, written notice of a proposed increase in the rates, charges or fees for water or sewer utility service has been provided to each customer of the utility providing the dates, times and location where such increases will be considered; and

**WHEREAS**, pursuant to law, ten (10) days' notice has been given by publication in a paper of general circulation in the City, notifying the public of this proposed ordinance and of a public hearing in the Commission Meeting Room of the City of Pompano Beach, Florida; and

**WHEREAS**, a public hearing before the City Commission was held pursuant to the public notice described above at which hearing the parties in interest and all other citizens so desiring had an opportunity to be, and were in fact heard; now, therefore,

**BE IT ENACTED BY THE CITY OF POMPANO BEACH, FLORIDA::**

**SECTION 1.** That Section 53.12, "Stormwater Fees," of the City of Pompano Beach Code of Ordinances is hereby amended to read as follows:

**§ 53.12 STORMWATER FEES.**

Within the City's fiscal year (FY), October 1<sup>st</sup> to September 30<sup>th</sup>, the monthly stormwater service charge per equivalent unit (ERU) shall be as follows:

FY 2017	\$3.93

FY 2020	\$4.82
FY 2021	\$5.15
FY 2022	\$5.52

<u>FY 2025</u>	<u>\$6.46</u>
<u>FY 2026</u>	<u>\$7.07</u>
<u>FY 2027</u>	<u>\$7.74</u>
<u>FY 2028</u>	<u>\$8.48</u>
<u>FY 2029</u>	<u>\$9.29</u>

**SECTION 2.** If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance that can be given effect without the invalid provision or application, and to this end the provisions of this Ordinance are declared to be severable.

**SECTION 3.** All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

**SECTION 4.** This Ordinance shall become effective upon passage.
