The grant funding would be used to purchase 62 SCBA units, 124 cylinders (45minute size), and 62 fitted face masks. The current SCBA units are two NFPA cycles removed, (NFPA 1981, 2007 compliant) with a range in age of packs and bottles from 14 years at the oldest to 8 years at the newest. They have reached the end of their serviceable life and are often in need of repairs, which is problematic for a busy fire-rescue agency. Perhaps more importantly, the current agency SCBAs lack many of the new safety and communications features found in modern SCBA units. There have been many enhancements in safety through the years, including improved ergonomics to reduce the risk of back injuries. The newer SCBA designs also help to reduce firefighter fatigue, which would assist in

decontaminated following firefighting operations. There are also features in newer models that offer materials that are more resistant to chemical and water penetration, which translates into a reduced risk of absorption of dangerous chemicals into the firefighter. Additional important SCBA improvements in safety resulted from the updating of NFPA standard 1981. For example, the 2007 standard required the low air alarm to sound when 25 percent of the cylinder's available air was left, but the 2013 edition requires the alarm to sound when the cylinder air is at 33 percent. The more recent version of NFPA 1981 also provided a standard for an improved safety feature in the SCBA facepiece insomuch as the face piece must now be able to withstand radiant heat at 15 kW/m2. interior firefighting crews is often difficult to understand due to the need to communicate to a radio microphone through the face piece, a significant amount of ambient noise arising from the fire, and interference of message communication because of the sound related to breathing from an SCBA. All of these communication problems have been addressed in the later editions of NFPA 1981. EBSS become standardized will also facilitate improved emergency operations when PBFR is operating at larger structure fires that necessitate a mutual aid response from external agencies. Currently, all structure fires require at least a ladder apparatus response from **Lighthouse Point Fire** Rescue. Having the EBSS in place for both agencies increases the chances that a firefighter having low or no air in the SCBA will be able to quickly connect to the EBSS irrespective of the differences from one fire department to the next. By purchasing newer model SCBA units, PBFR will realize the benefits noted above as well as other safety improvements. two (2) battalion chief model for management of day-to-day operations as well as during active firefighting and related emergency response incidents. The goal of the grant funding is to have one (1) of the grantfunded (if awarded) RIT packs carried on the second battalion chief's (Battalion 103) vehicle, and the second RIT pack placed onto Platform 11. which is the aerial device dispatched to all structure fires. These newer RIT packs would supplement the RIT packs that exist on only one (1) battalion chief vehicle (Battalion 63) and on our heavy rescue (Squad 52). our current configuration with two (2) RIT packs, there exists a risk that an incident will take place and no RIT pack will be available due to another emergency incident occurring at the same time or because the battalion chief is on another incident. These "simultaneous" incidents are occurring more frequently due to the continued escalation in call volume that the department has been experiencing in recent years. In the week prior to preparing this application, there were two structure fires that were occurring at the same time, which meant that at least one of those emergency incidents would occur without the benefit of the RIT pack for firefighter rescue. If this grant is awarded, Pompano Beach Fire Rescue will be able to ensure that at least one RIT pack - but likely two (2) - would be available for each and every structure fire within the service area or during automatic or mutual aid responses to surrounding cities. The department recently experienced a significant fire in which multiple crews were operating at a high rise structure fire. The crews were operating at remote locations due to the configurations of the stairwells and location of the fire. A reported incident of a firefighter entrapment would have resulted in a RIT pack being deployed up one of the two existing stairwells, and that RIT crew may not have been able to access a downed firefighter due to the location of the fire and how the crew approached the stairwell. If two RIT packs were available, two RIT crews could have easily been dispatched with each team using the two separately located stairwells, thereby improving the chances of being able to rescue a trapped or injured firefighter. It would also allow for the deployment of two (2) RIT crews from either the two different locations noted herein or by having both crews stage a couple floors below the fire. Purchase of the RIT packs will also facilitate compliance with NFPA 1500 8.8.2.1 and 8.8.2.2 insomuch as both standards having requirements related to rapid intervention teams and equipment. Having the RIT packs being sought in this grant would ensure that at least 1 (one) RIT pack would be available at all structure fires and other emergency incidents requiring a RIT standby and response, particularly if more than one incident is occurring at the same time. 8.8.2.1 requires "specialized rescue equipment' and an "SCBA," and the RIT packs would ensure that the department is compliant with this standard. Further, 8.8.2.2 requires a "RIC universal air connection," which is included in the RIT pack being sought in this grant opportunity.
