Scope of Services

A. Introduction

The City of Pompano Beach is commissioning Volkan Alkanoglu Design LLC. (ARTIST) for the design, fabrication, and installation of a sculpture that will be located at Pompano Beach Community Park on the southeast end along Federal Highway, 1660 NE 10th Street, Pompano Beach, FL 33060. A Call to Artists was posted on October 28, 2024, with a deadline of January 6, 2025. 153 artists submitted applications. At the May 22, 2025 PAC Meeting, the Committee recommended approval of Volkan Alkanoglu Design LLC and the artwork entitled *Infinity*. The artwork budget is \$150,000.00.

B. Objective

To continue to beautify and enhance the City of Pompano Beach.

C. Scope of Work

Artist's Design Proposal is attached and made a part of this Exhibit 2; however, the design will vary from the digital sketch as it is a model image.

In addition to the Work described in the Agreement, Artist shall timely

- Effectively communicate with City's Contract Administrator throughout the Term of the Agreement;
- Commence Work on the Project, to include fabrication of the Artwork in accordance with the Design Proposal approved by the Public Art Committee, upon the effective date of the Agreement and complete fabrication and installation of the Artwork at the location within six (6) months thereafter;
- Effectively communicate with the City's Contract Administrator and City's Building Inspections regarding requirements for the fabrication of the sculpture; and,
- Provide City a minimum of ten (10) professional photographs of the installed sculpture within two (2) weeks after the City's Acceptance.

D. Summary Schedule

This Agreement is for one (1) year after full execution by both parties; however, the artist shall complete the installation of the artwork in six (6) months after the Agreement is fully executed by both parties.

E. Inspections by the City

The CITY's Contract Administrator shall inspect the fabrication and installation of the Artwork at the five (5) completion phases described below to ensure compliance with the Design Proposal approved by the City Commission.

- 1st Inspection - Artwork fabrication is 25% complete
- 2nd Inspection - Artwork fabrication is 50% complete
- 3rd Inspection - Artwork fabrication is 75% complete
- 4th Inspection - Artwork fabrication is 100% complete
- 5th Inspection – Artwork installation

ARTIST shall notify the CITY's Contract Administrator in writing when each of the completion phases has been reached. ARTIST understands and agrees that the CITY's Contract Administrator has sole discretion to determine whether ARTIST has reached the requisite completion phase.

F. Compensation

For and in consideration of the mutual covenants and obligations herein as well as other good and valuable consideration received, ARTIST agrees to provide the Work required hereunder for CITY and CITY agrees to pay ARTIST a maximum not-to-exceed total amount of One Hundred Fifty Thousand Dollars (\$150,000.00) payable as follows:

- Invoice #1 for \$50,000.00 payable within fourteen (14) business days after this Agreement is fully executed by both parties;
- Invoice #2 for \$50,000.00 payable within fourteen (14) business days after the sculpture is 25% completed and approved by Contract Manager; and,
- Invoice #3 for \$30,000.00 payable within fourteen (14) business days after the sculpture is 50% completed and approved by Contract Manager; and,
- Invoice #4 for \$20,000.00 payable within fourteen (14) business days after City's Final Acceptance of the Artwork, receipt of a proper invoice for the Work, final professional images are sent to the Contract Administrator, and satisfactory completion of the Catalogue Form attached as Exhibit 4.

G. PROJECT LOCATION

The sculpture will be located at the Pompano Beach Community Park on the southeast end along Federal Highway, 1660 NE 10th Street, Pompano Beach, FL 33060.
