**RE: Bridge Powerline – Termination/Release of Declaration of Restrictive Covenants  
Regarding Project Access – correction to ownership information**

Dear Maggie,

On March 27, 2018, the Commission approved a Termination/Release of the Declaration of Restrictive Covenants regarding Project Access (ORB 46881 PG1473). The Termination/Release only cited one property owner: Bridge Powerline LLC, and the City approved and executed the instrument as it was presented. However, prior to transmitting the Termination/Release to Broward County for execution, the title search revealed that there are now two (2) owners of the property covered by the Termination (not one). Unbeknownst to me, approximately a few days before the Commission hearing, Bridge Powerline LLC, carved out and transferred the outparcel of the property to another Bridge entity (Bridge Powerline Frontage LLC). Because the Termination/Release needs to be signed by all owners, we are respectfully requesting the City to re-execute the Termination/Release with the updated ownership information and signature pages. Other than the additional owner, signature page and updated address, there are no substantive changes.
