DEPARTMENT OF TRANSPORTATION'S 2018-2020
MOBILITY PROJECTS PLAN FOR THE CITY;
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of Pompano Beach ("City") has funds to construct the six mobility projects (the "Projects"), fully or partially within the City of Pompano Beach, as is more fully set forth in Exhibit "A," attached hereto and made a part of this Resolution; and

WHEREAS, the Projects are on City roads within the City of Pompano Beach ("City"); and

WHEREAS, Florida Department of Transportation ("FDOT") will be the agency responsible for design and construction activities on the Projects; and

WHEREAS, FDOT requires a resolution supporting its role as the Projects' designer and construction administrator; and

WHEREAS, the City endorses FDOT's delivery of the projects; and

WHEREAS, City, as the owner of the Projects' right-of-way, is committed to continue funding the operation and maintenance of the six projects referenced in the attached Exhibit "A."

WHEREAS, the Projects will further the goal of the City to support the development, design and construction of sustainable, multi-modal transportation facilities throughout the City, to meet the demands of residents, travelers, businesses and the community; and

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO
BEACH, FLORIDA:**

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct, and are hereby made a part of this Resolution.

SECTION 2. The City supports FDOT's Projects, as listed on the attached Exhibit "A," to improve conditions for bicyclists and pedestrians.

SECTION 3. The City supports FDOT as the project designer and construction administrator.

SECTION 4. The City endorses FDOT's delivery of the projects.

SECTION 5. This Resolution shall become effective upon passage.
