A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE A FUTURE ADVANCE AGREEMENT WITH, AND ACCEPT A PROMISSORY NOTE FROM, SONATA APARTMENTS, LTD., TO PROVIDE FINANCIAL ASSISTANCE IN THE FORM OF A \$250,000 LOAN TO COMPLETE CONSTRUCTION OF A 121-UNIT MIXED USE, MIXED INCOME HOUSING DEVELOPMENT LOCATED WEST OF DIXIE HIGHWAY BETWEEN NW 6TH STREET AND NW 8TH COURT, AS PROVIDED AND SECURED BY THE FEBRUARY 3, 2022 MORTGAGE AND **SECURITY** AGREEMENT EXECUTED BETWEEN THE PARTIES; PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That a Future Advance Agreement between the City of Pompano Beach and Sonata Apartments, Ltd., and the related Promissory Note, to complete construction of a 121-unit mixed use, mixed income housing development located west of Dixie Highway between NW 6<sup>th</sup> Street and NW 8<sup>th</sup> Court are approved, a copy of the Agreement and Note are attached and incorporated by reference as if set forth in full.

SECTION 2. That the proper City officials are authorized to execute the Future Advance Agreement between the City of Pompano Beach and Sonata Apartments, Ltd. to provide financial assistance in the form of a \$250,000 loan and to accept the related Promissory Note executed by Sonata Apartments, Ltd.
