Dear Transportation Partner,

*Thank you for your continued support with the implementation of the 2016 Transportation Investment Generating Economic Recovery (TIGER) grant. By this time you should have received from the Florida Department of Transportation (FDOT) the Local Funded Agreement (LFA) for **Hammondville Road**. Please note this amount has been updated to include a 20% contingency (20% of total local contribution). This is due to the increased cost of construction and to ensure potential additional costs are covered if the total accepted bid were to come in higher than expected. The increase in cost of construction was discussed at coordinating meetings held earlier this year.*

*To minimize negative impacts to the project schedule, satisfy the deadlines set forth by FHWA and not jeopardize TIGER funding, we respectfully request the remaining local contribution for construction to be forwarded to the Department in an expeditious manner. The Broward MPO is requesting the remaining local contribution for the construction of your respective **TIGER** project as per the table below:*

*Please ensure the LFA for the **\$3,672,180.00** is signed and returned to the Department by **December 31st, 2018** and the funds is delivered to the department no later than **January 15th, 2019**. This will ensure expeditious project delivery and will allow the Department to move forward with the advertisement and construction of the TIGER grant to meet the FHWA schedule.*
