Ms. Aycock about "as viewed from" in 3D. Mr. Keester-O'Mills stated it should read "as viewed from the street."

Ms. King inquired about size and width restrictions for tractor trailers. Mr. Keester-O'Mills said it is approximately 21 feet for this type of use, but they can consult the code and confirm.

Chair Stacer opened the public hearing. No one came forth to speak. Chair Stacer closed the public hearing.
