REVOCABLE LICENSE AGREEMENT

WHEREAS, J.C.B. INTERNATIONAL, INC. is the owner of the property located on the Southeast corner of 16th Street and State Road AlA in the City of Pompano Beach as more particularly described in Exhibit "A" attached hereto; and

WHEREAS, Section 156.04(E) of the City of Pompano Beach Code requires that a free standing sign be located no less than four (4) feet from any road right-of-way line which has been constructed by the City to be the ultimate right-of-way; and

WHEREAS, the Broward County Trafficway Plan contemplates the acquisition of additional right-of-way on both the east and west side of State Road AlA; and

WHEREAS, J.C.B. INTERNATIONAL, INC., wishes to construct a free standing sign four (4) feet from the existing right-of-way line of State Road AlA; and

WHEREAS, the City of Pompano Beach is agreeable to same as long as the free standing sign will comply with the four (4) foot setback requirement in the event that an additional right-of-way for State Road AIA is planned or acquired; and

WHEREAS, in order to accomplish this purpose, the parties have agreed to enter into this Revocable License Agreement as set forth below.

THIS AGREEMENT is between the City of Pompano Beach, a municipal corporation of the State of Florida, (hereinafter referred to as "CITY") and J.C.B. INTERNATIONAL, INC., (hereinafter referred to as "LICENSEE").

1. The above recitals are true and correct and are

- 2. LICENSE GRANTED; The CITY hereby grants to LICENSEE the revocable right, license and privilege to erect a free-standing sign in accordance with the CITY's applicable regulations, four (4) feet from the existing right-of-way of State Road AlA.
- 3. TERM; The term of this license shall run until such time as the LICENSEE is notified that additional right-of-way for State Road AlA has been either (a) acquired by a governmental entity; or (b) that construction plans have been approved by Broward County or the State of Florida which includes the use of the additional right-of-way for the expansion of State Road AlA, whichever occurs first; or a determination is made by the CITY that this Agreement violates the Broward County land use plan, the Broward County Trafficway Plan, or the City of Pompano Beach land use plan, as they may be amended from time to time. Notice of termination shall be sent in writing, giving LICENSEE sixty (60) days to remove or relocate said sign.
- 4. REMOVAL OF SIGN UPON TERMINATION: Immediately upon the termination of this Revocable License Agreement, LICENSEE shall remove or relocate the free standing sign permitted hereunder so as to comply with the four (4) foot set back requirement from the ultimate right-of-way line of State Road A1A at its own expense with no right to compensation of any kind from the CITY.
- 5. INDEMNIFICATION: LICENSEE agrees to indemnify and hold harmless the CITY, its officers, agents and employees from any and all claims resulting from or relating to the placement of said sign

· as indicated.

- 6. AMENDMENTS: No modification, amendment or alteration of the terms or conditions contained herein shall be effective unless contained in a written document by the parties hereto, with the same formality and of equal dignity herewith.
- 7. NOTICES: Any notice or demand, which under the terms of this Revocable License Agreement or by any statute or ordinances, given or made by a party hereto shall be in writing and shall be delivered by Certified or Registered mail sent to the other party at the address set forth below, or to such other address as such party may from time to time designate by notice.

- 8. ENTIRE AGREEMENT: This Revokable License Agreement embodies the entire agreement between the parties. It may not be modified or terminated except as provided herein. If any provision herein is invalid, it shall be considered deleted herefrom, and shall not invalidate the remaining provisions.
- 9. LAWS AND ORDINANCES: LICENSEE shall observe all laws and ordinances of the CITY, County, State and Federal Agencies directly relating to the operation of the property described in Exhibit "A". This Agreement is subject to the requirements of the Broward County

Land Use Plan, the Broward County Trafficway Plan and the City of Pompano Beach Land Use Plan, as they may be amended from time to time.

Agreement shall be recorded in the public records of Broward County, Florida. Upon termination of this Agreement, a document of equal dignity to this document shall be executed and recorded by the CITY. The expense of recording any and all documents required pursuant to this Revocable License Agreement shall be born by the LICENSEE.


