*Condition of the Development Order*

This current re-submittal is to introduce the latest Artwork updates as requested and revised Building Colors to the Architectural Appearance Committee (AAC).

*The changes include:*

- Accent Colors change from the original Supreme Green to two shades of blue (In the Navy & Favorite Jeans from SW) - (See attached Material Boards).
- A body color change from City Loft to Natural White - (See attached Material Boards).
- Addition of the Wave Art & Sculpture required by the original AAC D.O.
- Addition of the Artist information required by the original AAC D.O.
- REC Building Elevations were slightly tweaked to match the Interior Floor Plan Layout updates from IDDI (ID & Design International).

*Original Board Conditions*

1. A professional artist must be used to create the wave artwork on the building as well as the sculpture.

The sculpture is fabricated out of steel and can be customized in terms of size. As pictured, the work is 196.9 W x 94.5 H x 59.1 D in, and the price is \$25,000. Lead time is 3 months.

Inspired by Florida's local flora and fauna, this artwork depicts birds and leaves in a palette that complements the surrounding environment, the exterior architecture and also elements of the interior design.
