Ms. Jean Dolan, Principal Planner, introduced herself to the Board and stated the applicant is requesting to abandon a 15-foot strip of right-of-way on the west side of Dixie Highway between NW 15th Place and NW 15th Court in order to more easily develop the parcel into 10 townhouse units. The project design includes two, two-story buildings along Dixie Highway with ground floor parking, improved grading, drainage and landscape design. The project's Minor Site Plan and Flex Allocation requests are being reviewed concurrently. Development Services staff recommends approval of this ROW abandonment with the retention of a utility easement. Staff notes the one condition of approval provided in the staff report has already been met so there are no conditions of approval.

Given the information provided to the Board, staff provides the following alternative motions for the Board's review:

Alternative Motion I

Recommend approval to the City Commission as the Board finds that the right-of-way abandonment meets the standards of Section 155.2431D.1. & 2.
