The Applicant Landowner is requesting SPECIAL EXCEPTION approval, as required by Section §155.4219(D) [Automotive Parts Sales with Installation] and Section §155.4219(E) [Automotive Repair and Maintenance Facility] of the City’s Code of Ordinances in order to utilize the subject property (Zoning District: B-3) to provide sales, installation, repairs, and maintenance services for automotive vehicles.


