- COORDINATE FIRE ALARM DEVICES AND PANELS WITH ELECTRICAL DRAWINGS
 - REFER TO FIRE PROTECTION DRAWINGS FOR SPRINKLER HEAD LOCATIONS
 - REFER TO ELECTRICAL DRAWINGS FOR FIRE ALARM DEVICE LOCATIONS
 - REFER TO ELECTRICAL DRAWINGS FOR EMERGENCY LIGHT LOCATIONS
 - ORDINARY HAZARD OF CONTENTS (NFPA 38.1.5.1)
 - A FACTOR OF 0.2 INCHES OF WIDTH PER OCCUPANT HAS BEEN USED TO CALCULATE MINIMUM DOOR AND CORRIDOR EGRESS CAPACITY
 - A FACTOR OF .3 INCHES OF WIDTH PER OCCUPANT HAS BEEN USED TO CALCULATE MINIMUM CLEAR WIDTH OF STAIRWAY EGRESS CAPACITY
- AUTOMATIC EXTERNAL DEBRILLATORS (AED) AND STOP THE BLEED KITS (SBK) SHALL BE INSTALLED AS DEFINED IN NFPA 101, LIFE SAFETY CODE, ON EVERY OTHER FLOOR BEGINNING ON THE FIRST FLOOR. THE AED AND SBK SHALL BE PLACED NEAR THE ELEVATOR(S) BEGINNING IN THE FIRST-FLOOR LOBBY (FIRST FLOOR, THIRD FLOOR, FIFTH FLOOR, ETC.) REFER TO BROWARD FIRE CODE AMENDMENTS SECTION F-121 FOR ADDITIONAL INFORMATION FOR LOCATION, MOUNTING, INVENTORY, TRAINING, AND INSPECTION OF REQUIRED EQUIPMENT.
