**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING EIGHT (8) STORM DRAIN MURAL DESIGN PROPOSALS OF WILLIAM SAVARESE, INC. FOR FABRICATION AND INSTALLATION IN THE CITY'S INNOVATION DISTRICT PURSUANT TO THE MULTI-YEAR PUBLIC ART PROJECT ENTITLED, "ASPHALT ART – THE CROSSROADS CONNECTION"; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on April 28, 2020, pursuant to Resolution 2020-165, the City Commission approved a Grant Award Agreement between the City of Pompano Beach and the Community Foundation of Broward whereby the City accepted a matching grant in the amount of \$30,000 for the multi-year project entitled, "Asphalt Art – The Crossroads Connection" (the "Asphalt Art Project") to be installed in the City's Innovation District;

**WHEREAS**, on December 8, 2020, pursuant to Resolution 2021-34, the City Commission approved William Savarese, Inc. ("Savarese") as the artist for the Asphalt Art Project wherein Savarese was commissioned to conduct certain community engagement activities to assist Savarese's design, fabrication and installation of eight (8) storm drain murals in the City's Innovation District; and

**WHEREAS**, pursuant to Section 160.04 of the City's Code of Ordinances, the Public Art Committee ("PAC") is empowered to make recommendations to the City Commission regarding certain public art issues, including artist selection and location of public art; and

**WHEREAS**, at its meeting on March 18, 2021, the PAC recommended approval of the eight (8) storm drain mural designs depicted in the Design Proposals attached hereto and made a

part hereof as Composite Exhibit 1 for fabrication and installation at select locations in the City's Innovation District pursuant to the Asphalt Art Project.

**BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:**

**SECTION 1.** That the City Commission approves the eight (8) Design Proposals attached hereto and made a part hereof as Composite Exhibit 1 for installation at select locations in the City's Innovation District pursuant to the multi-year public Asphalt Art Program.

**SECTION 2.** This Resolution shall become effective upon passage.
