### A. AUTHORITY TO SUBMIT APPLICATIONS

- Unless expressly stated otherwise in this Code, applications for a development permit reviewed under this Code shall be submitted by:
- a. The owner, contract purchaser, or any other person having a recognized property interest in the land on which development
   b. A possess of the contract purchaser, or any other person having a recognized property interest in the land on which development
- b. A person authorized to submit the application on behalf of the owner, contract purchaser, or other person having a other person.
- 2. If there are multiple owners, contract purchasers, or other persons authorized to submit the application, all such persons shall sign the application or a letter or document consenting to the application.

By signing below, I acknowledge that development applications must have a determination by the governing municipality of approved, approved with conditions, or denied within 120 days from a complete submittal for projects that do not require final action through a quasi-judicial hearing or a public meeting and within 180 days from a complete submittal for projects that do require final action through a quasi-judicial hearing or a public meeting per FL Stat § 166.033 and the Pompano Beach Code Section 155.2303.F.3. It is the applicant fails to resubmit an application within 30 calendar days after being first notified of deficiencies of the submittal, the application approvals are not received within the allotted timeframe the application will automatically be denied unless both the City and the applicant agree to an extension of time (155.2303.I).
