

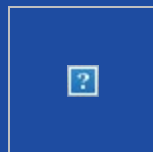

The Agency is implementing a new procedure for the dissemination and receipt of Letters of Agreement (LOA) that will improve efficiency and accuracy of the State's record keeping. As of July 1, 2022, all LOAs will be sent and received by the Agency via DocuSign. DocuSign is a secure and HIPAA compliant service that tracks signatures and countersignatures in an auditable format.
